NBC TASKS SEARCH FM ON EDU. BROADCASTING

The National Broadcasting Commission (NBC), has urged the institution's radio station, Search FM 92.3 to develop more programmes on educational broadcasting in order to help enhance literacy level in Niger State.

This assertion was made known on Tuesday, September 03, 2013 at the Council Chamber when the New Zonal Director in charge of NBC Abuja Zone, Mrs. Francisca Aiyetan paid a familiarisation visit to the station and the University Management.

Mrs. Aiyetan said the station should be used for dissemination of knowledge through tutorials and other educational related programmes for the students and other listeners who do not have the opportunity of formal education.

The Zonal Director, applauded the University Campus Radio for complying with NBC Codes and urged them to ensure 80% of local contents in their programming in order to encourage creativity among Nigerian youths.

She also called on the station to assist NBC in educating the masses on the issue of trado-medics.

She further commended the University Management for providing the necessary support for the station to stay afloat and for allowing the station to participate in all NBC organised programmes. Responding, the Vice-Chancellor, Prof. Musbau Adewumi Akanji, **FNSBMB**, who was represented by the DVC (Academic), Prof. Abdullahi Bala thanked the Zonal Director for finding out time to visit the station and for all the advise given towards moving the station to greater heights.

Prof. Bala said the University Management is satisfied with the performance of Search FM team in the areas of its primary responsibilities and assured the NBC team of the University continous support to the station.

He further appreciated NBC for all they have done for the station and informed them that the University is working round the clock towards getting a befitting permanent studio for the station after the fire incident.

In his vote of thanks, The Chairman, University Campus Radio Board, Dr. Segun Oyero said the station would continue to be self regulated by adhering strictly to NBC rules and regulations.

AMB. GANA URGES UNIVERSITIES ON CONSULTANCY SERVICES

The Permanent Secretary, Cabinet Secretariat in the Office of the Secretary to the Government of the Federation **(OSGF)**, Ambassador John Gana has called on universities in the country to do more in the area of consultancy services for private companies and individuals in order to generate funds to their institutions.

The Permanent Secretary made this disclosure when he led officials from

OSGF to the institution to ascertain the level of implementation of the Smart Boards given by National Universities Commission **(NUC)** under the Nigerian Universities Electronic Teaching & Learning Platform on Monday, September 02, 2013 at the Council Chamber, Main Campus.

Amb. Gana urged Nigerian Universities to learn from their counterparts abroad by partnering with companies in the area of research and project implementation such as the on-going at Shiroro Dam, Niger State.

On the issue of shortage of softwares noted during the supply of the Electronic Boards, the Permanent Secretary advocated for collaboration between Nigerian Universities and the suppliers in order to ensure that all components of the Smart Boards are supplied based on Universities needs.

In her opening remarks, the Permanent Secretary, Special Duties OSGF, Dr. Jemila Shuara said the team visit was to ascertain the level of deployment and implementation of the Smart Boards by the University in order to see how they can add value to the process of decision making and learning in the country. Boards from National Universities Commission (NUC) and bought additional fifty Smart Boards to complement NUC efforts.

He said the Electronic Teaching Boards have been installed in Lecture Halls, Board Rooms across various Schools and thanked the Federal Government for selecting FUT, Minna among the eighteen Universities that benefited from the project.

Earlier, the University Schedule Officer E-Teaching & Learning, Dr. Ikechukwu Diugwu said the University has ensured effective usage of the Electronic Smart Boards for teaching and learning.

He informed the delegation that most of the Smart Boards were delivered to the University without softwares and some other components which has hampered total utilization of the boards.
