ABSTRACT

This paper addresses the issue of more effective and efficient handling of doctor-patient relationship.

The idea is to use the hospital management software to extend hospital-patient/doctor-patient relationship beyond physical and logistical limitation of face to face consultation in patient management. Hospital management software can provide an extension of the doctor by interacting with the patient via a computer.

CHAPTER ONE INTRODUCTION

It is imperative to begin strengthening health management information system with an analysis of the strengths and weaknesses of existing information systems and sharing findings with all stakeholders. All would agree on the need for reformation of various vertical program-specific information systems into a comprehensive, integrated, decentralized and action-oriented simple system. As a first step towards conceptualization and design of the system, a minimum set of indicators should be identified and a strategy formulated for establishing a system. The design focus will be on the use of information in planning, management and improvement of quality and coverage of services. All health and support personnel should be trained, employing a training of trainers cascade approach. Information management and use should be incorporated into the pre-service training curriculum and the job description of all health workers and support personnel. Quarterly feedback, supportive supervision visits and annual reviews will be institutionalized. Civil society organizations are to be involved in monitoring coverage of health services at local levels.

The conclusion is that, no matter how good the design of an information system, it will not be effective unless there is internal desire, dedication and commitment of leadership to have an effective and efficient health service management system in the country.

CHAPTER TWO

LITERATURE REVIEW

Adepoju, (2002) pointed out that the alarming rate at which computer is advancing has made it possible for it to cut across every field of life. As a result of this, the development of expert systems which allow a computer to perform task that require human intelligence is on the increase.

Onifade (2001); assessed that the objective of the study is to assess the method of computerizing the hospital using hospital management software. The process of the diagnosis of various diseases is based purely on the signs and symptoms manifested, and the laboratory result of each patient blood tested. Based on this, Comprehensive Computer Language was designed to aid in laboratory system of Malaria Parasite.

Fagbemi (2000); attempted to investigate and discovered that the need and demand for reliable and efficient automated Medical Information System especially for the Raw Material Research and Development Council (RMRDC) in-house Clinic is enormous. In this work, an attempt was made to investigate the existing system (manual) and a critical evaluation of the automated system with respect to its claimed objectives of reliability, extensibility and high performance. The design approach is structured and programming techniques and data structure used were highlighted. The software runs on Fox Pro and the systems response time shows that the software is efficient.

Sidi (2002); in his work using the Laboratory Unit of General Hospital Minna, stressed that computerization of that unit will go a long way to solve the problems of record keeping. These problems ranging from slow response to report requested to loss of data made access to test result difficult. She suggested the development of software suitable for this record keeping purpose and that a database Management System package is required.

Campbell, (1997); Lippeveld et al. (2000) discovered that Information Systems are increasingly important for measuring and improving quality and coverage of health services. The global shift from curative to preventive care, from hospital care to community and public health care, from centralized to decentralized health care, from a specific project approach to a comprehensive

sectoral approach, has necessitated the restructuring of fragmented health information systems into single comprehensive health and management information systems. The restructuring of health information systems has become an important trend in the entire developing world since the adoption of primary health care as a global strategy for achieving the 'health for all' goals (Campbell 1997). Ever since, the restructuring or strengthening of information systems has been a learning process. A standard package that could be adapted to all situations has not yet been discovered. Hundreds of academics and practitioners are continuously contributing to the better understanding of the design and role of health information systems. Pioneering countries started with trial and error, and the countries starting at a later stage are benefiting from the lessons learned by their predecessors.

Ramneet Singh Chadha et al (2008) in their paper presentation mentioned that the Operation Theatre is a critical area of the hospital. Therefore, Operation Theatre Management System (OTMS) is an important component of the Hospital Information Management System (HIMS). The paper presented the design and implementation aspects of an OTMS. The innovative features like Generic Dynamic Template for capturing various types of data, Generic Consent forms, Alert Facility, Vital Monitoring and Graph Plotting facility, etc. have been integrated in this module. Design aspects related to check list facility, patient monitoring utility, video streaming, and decision support system, etc. implemented as a part of this module were also presented.

Oxford Journals, (2005) cited that as in many developing countries, lack of reliable data and grossly inadequate appreciation and use of available information in planning and management of health services were two main weaknesses of the health information systems in Malawi. Malawi began strengthening its health management information system with an analysis of the strengths and weaknesses of existing information systems, sharing findings with all stakeholders. All were agreed on the need for reformation of various, vertical programme-specific information systems into a comprehensive, integrated, decentralized and action-oriented simple system. As a first step towards conceptualization and design of the system, a minimum set of indicators was identified and a strategy was formulated for establishing a system in the country. A midterm review of the achievements of the health information system judged it to be one of the best in Africa. For the first time in Malawi, the health sector has information by facility by month. Yet very little improvement has been noted in use of information in rationalizing decisions. The conclusion is that, no matter how good the design of an information system, it will not be effective unless there is internal desire, dedication and commitment of leadership to have an effective and efficient health service management system.

It was concluded by suggesting that taking full advantage of lessons learned by pioneers around the world and others who had recent experience of HMIS reform, Malawi conceptualized, designed and implemented a simple, decentralized, action-oriented HMIS. Though the achievements made in 4 years are quite remarkable, the main aim of optimizing data quality and use have not yet been fully achieved. The support for further strengthening must be continued until a culture of information is created in the entire health sector.

CHAPTER THREE

SYSTEMS ANALYSIS

3.1 Diagnosis of Disease

In this part of world (Nigeria) diagnosis of disease is done or carried out manually. There are two

way of diagnosis:

A. Clinical diagnosis

B. Laboratory diagnosis

Clinical diagnosis is carried out by the doctor before proceeding to the laboratory for

confirmation. In the case of laboratory request form is obtained and filled by the doctor with the

patient clinical information, before it is sent to the laboratory, for laboratory diagnosis.

Clinical Diagnosis A.

This involves examining the patient. It is based on:

i. Medical examination (physical)

ii. Medical history

i. **Medical Examination (Physical)**

In the course of this examination, certain things are watched out for, such as signs symptoms;

Signs: These are what the doctor can see or elicit (i.e. assessment of the general appearance of

the patient).

Symptoms: This is what the patient complains about.

ii. **Medical History**

These include: name, tribe, place of origin, hospital number, age and sex, patient occupation,

religion, complain, systemic review, past medical history, family history, social history and

drug history.

- c. Computer Tomography scans (CTS)
- d. Magnetic resource imaging (MRI)

A. Medical Microbiology

C. Morbid Anatomy

- II. Biopsy and histology: This involves taking tissue samples, preparing it and looking at it under microscope in order to diagnose disease.

CHAPTER FOUR

- > Do you feel well at night?
- > Do you feel nervous?
- > Do you feel dizzy?
- > Do you stool frequently?

4.3 Software Design

Good user interface design is critical to the success of a system. An interface that is difficult to use will at best result in a high level of user error. At worst, if information is presented in a confusing or misleading way, users may misunderstand the meaning of the information. They may initiate a sequence of actions that corrupt data or even cause catastrophic system failure, assembling the specification above result in the interface structure diagram below:




Figure 4.1 Hospital Management Software Interface Structure

4.4 Hospital Management Software Interface Structure

The hospital management software interface diagrams shown above, shows how the software interfaces is displayed. The diagnosis interface is the first interface; it has program title written on it. It is followed by personal data interface; it prompts patients/user to provide his/her data. It is followed by another interface, which asked series of questions, expected to be answered by the patient. This enables diagnosis to be carried out. Finally display result interface is followed, this contains patient data, the name of the type of sickness a patient is having and an ok button which when clicked returned control back to the first interface, ready for another diagnosis for different user. This process is a recursive cycle. Hospital management software is distinct from other traditional software, as a result of it interaction with users.

4.5 Software Implementation

Implementation is to set up the entire system and testing is using the data design and the system detest is using the data design and the system design phase. 




Figure 1: Login Page




Figure 2: Client Registration Page




Figure 3: Doctor's Remark Page




Figure 4: Pharmacy Page




Figure 5 : Admin Page




Figure 6 : Radiology Page




Figure 7: Laboratory Page
