ABSTRACT

The need for efficient, effective and fast means of processing data in all areas of human endeavour made the use of computers desirable especially in day to day running of affairs for individual and corporate organisations.

This study is an expert system produced to serve as an alternative to manually operated procedures as obtained in the department of land with regards to land allocation, collection and payment of ground rents and other related activities surrounding acquisition of landed properties in the state.

The Project highlights the importance of land use decree promulgated in 1978 to give land only to those in need.

The approach adopted is a management information system (MIS) which involves carrying out analysis (investigation) on the current system with the sole objective of providing an improvement. The ADDBMS package database iv version was chosen for the task because it provides facilities for retrieving, generating and updating. It also allow many end users with a variety of application packages.

CHAPTER ONE

1.0 OVERVIEW ON LAND.

Land is the basic natural resources without which life on this planet (earth) would be greatly impossible. Control of the land is the key to power (attendant social and political influence) and wealth and income distribution. It is a natural resources endowed for mutual benefit of mankind irrespective of race or creed. Collins Cobuild dictionary has this to say, "it is an area of ground, especially one that is used for a particular purpose such as farming or building".

From time, land has been one resources that sends communities into conflicts with one another, just because of its unlimited importance to the growth and development of mankind. (Human race).

Bearing this in mind, individual, corporate organisations and Government alike has a regulatory organ that is charged specifically, to administer this natural resources. Accordingly, on the 29th March, 1978, a land use and allocation decree was promulgated for Nigeria. The decree, vested all land comprised in the territory of each state in the federation in the hand of Governor of such state which is held in trust and administered for the use and common benefit of all Nigerians.

To put check on the part of the Governor, on matters pertaining to land management and control, the decree also compelled each state in the federation to

constitute an advisory committee charged with the responsibilities of:-

- a) Advising the Governor on any matter connected with the management of land;
- b) Advising the Governor on any matter connected with the resettlement of persons affected by the revocation of Right of Occupancy on the ground of overriding public interest;
- c) Determining disputes as to the amount of compensation payable for improvement of land.

The organ charged to accomplish these responsibilities is the department of lands in the state ministry of works and transport. The department oversees on behalf of government all transactions on land to individual applicant or corporate bodies which are used for residential, commercial, agricultural or mining activities or for the benefits of all Nigerians such as public schools, hospitals and markets.

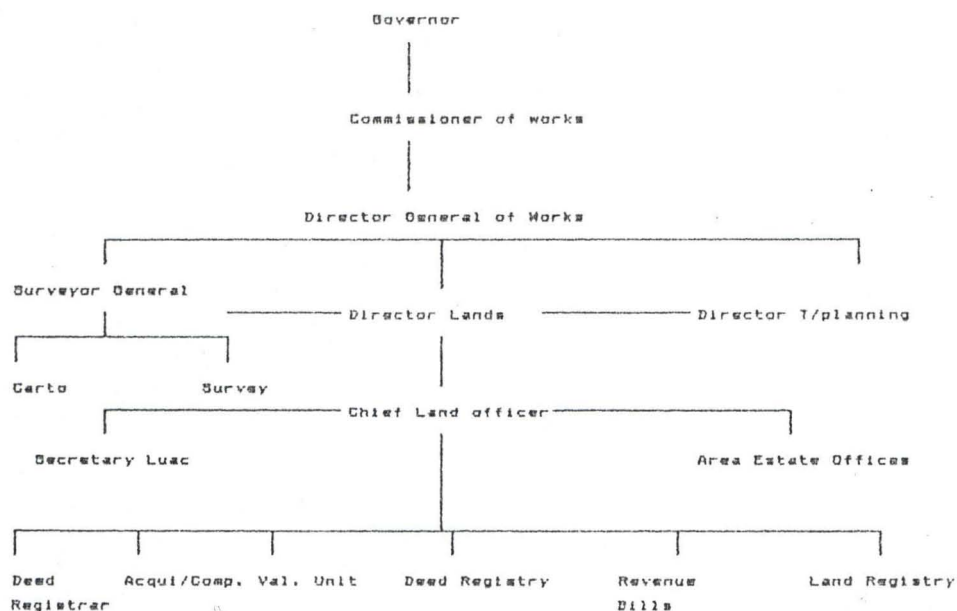
In conjunction with two sister related departments, i.e. survey and town planning, the lands department effectively carry out these responsibilities. Each of the three departments is headed by an equivalent of a director. Due to the limited scope of the project, a brief remark of these related departments shall be outlined:

- a) The survey department has surveyor General as its head. Working together with him are the surveyors and the cartographers. The surveyors

provides bearing and distances tied to the ground control points, while the cartographers translates the resultant field work onto the sheet of paper or cloth generally referred to as maps.

b) The town planning department has a director as its head with him are other subordinates down the hierarchy. The department concerned its self with planning and designing of layouts, twon and country planning and beautification of our environments.

Figure 1.1 shows the organisational chart of land department with related departments.



As for organisational chart, here are brief on the section that make up the department of land:

Land/Open Registry: All files relating to applicant seeking any information of land are kept. These are in file cabinet system.

Bill/Revenue: The bills section prepares all bills such as application forms fee, ground rent, grant, c of o,

etc. and keep record of same. While the revenue collect all revenue on behalf of the government by the department.

Deed Registrar: Takes charge of Certificate of Occupancy, prepares the initial bills and sent same for governor assent through appropriate routing channels.

Land & Allocation Committee: The committee performs an advisory rule on behalf of the governor. It allocates, monitors and sometimes revokes land where necessary if not used for the good of humanity.

Compensation and Requisition:

All lands belongs to government according to land use decree of 1978 but certain custodian who dwell on such lands need to be compensated for keeping it in their custody. These type of compensation is done where there is need for agricultural farm, layout, mineral resources beneath the ground, for school, hospital or markets etc.

Valuation Unit: This section evaluate all government buildings and those to be rented for its personnel.

1.1 OBJECTIVES OF THE PROJECT.

For everything human being endeavour to perform, it must have a compelling reason or purpose, if not, he should not in the first place dream of it.

Computer became a fool that is contributing to advances in virtually all fields. Its advent and subsequent application of computer in solving tasking problems calls for a critical study on the manual process of allocating, using and investigating issues related to land in Nigeria with particular reference to Niger State.

To achieve these overall objectives a computerized land record system shall be developed and tailored toward:-

- i. Eliminating or reducing to minimum the corrupt practices surrounding allocation of land;
- ii. Provides a more accurate and efficient management or assessment of land resources for interested users;
- iii. Proper means of storing and retrieving records on lands so as to reduce cases of missing or misplaced files multiple allocation;
- iv. Reduces cost on overhead and stationery; and
- v. Provides security on vital information in respect of land.

1.2 RESEARCH METHODOLOGY

There is no hard and fast rule regarding the method adopted to any project or research. This is not an exception several investigative technique have been employed. Among such techniques are lecture notes, published materials, interview, document review, observations and so on.

This project is undertaken in stages as outlined below:

a) feasibility study:

This is otherwise referred to as preliminary investigation embarked upon to determine whether or not the proposed project is desirable.

b) System Analysis.

The current system under investigation must thoroughly be examined so as to profer solution. It is not a problem solving stage but an attempt is made to analyse the current system with a view to recommend for either a new system or enhanced the current system.

c) Software development.

This is the final stage of the research. Coding and designing using a programming language is developed. The ability of the software to solve initial problems identified will be examined by the use of test data.

1.3 SCOPE/LIMITATION OF THE PROJECT

The scope of a computerised land allocation system are very wide. This does not particularly goes beyond department of lands, and Niger state. But states with similar setting may wish to incorporate with a little or no modification. However the project is limited to layouts customary land/convension mortgages, deed Registrar LUAC valuation and open registry. The project is limited as result of time, cost and those official with vital information.

1.4 IMPORTANCE OF COMPUTER

William Fuori in his book introduction to the computer, has this to say. "There isn't a home or a business that hasn't felt the impact of the electronic computer. Computer are used to calculate gas, water and electric bills, control electric equipment during surgical operations, control the take off and landing of rockets and space vehicles, control intricate chemical processes, predict enemy troop movement during wartime, and most important to the business world, computers are used to control the financial and management activities of business."

Although, is often argued that computer saps the motivation and intelligence of people who should be making decision, and instead turn them into information processors. This is because of the volume of data generated, and processed with short period of time, which made computer inevitable. Since this could not be accomplished manually

with any degree of efficiency. However, computer can be said to be an electronic derive that is capable of accepting data, processing it and produce the find result (output) accurately and efficiently without human intervention if given adequate instruction referred as computer program.

From the aforementioned, it will be deduced that comoputer performs some tasks:

i. Though computer saps human motivation and intelligence, it performs repetitive tasks without monotony;

ii. In the field of education and entertaining, computer serves as an aid;

iii. Computer are used in many field of endeavour such as medicine, science, technology, space and land resources;

iv. To reduce complex calculation into smaller unit(s), computer was thought and developed.

v. Reliable logical comparison between things are made possible with easy, and efficient using computer.

vi. Complex and hazandous task to human being such as space vehicle, Geology, mining, under sea are undertaking with computer;

vii. Efficiency in filing, storing, retrieving of processed data and information is achieved using computer.

1.4.1 CLASSIFICATION OF COMPUTERS

Computers for now can best be classified based on the following criteria of logic or mode of input, purpose and size.

a) Logic or mode of input.

The logic or mode of input of nay computer is centred on whether its an analog, digital or hybrid.

Analog computers are used in measuring and compares physical components/changes and variable in form of mathematical equation. It process variation in speed, chemical composition, temperature, amount of current flowing through a conductor etc. and is widely industrially and scientifically. It has no memory hence only measures or compares data or value. eg. car speedometers, slide rule, non digital etc.

Digital computers are present day computers which performs arithmetic operation and access logical decision according to instruction or program. Data are represented in digits.

Hybrid computers are a combination of desirable feature of an analog and digital computers. They are powerful device used in solving sophisticated problems.

b) Purpose.

With regard to purpose, we have general purpose computer which are used in most school/business organisations while special purpose or dedicated computers are designed for special task. Eg. Computers used in monitoring space shuttle or weather forecasting.

c) Size.

In term of size, all computer differs in prices, speed storage and processing capabilities.

i. Super of maxi computer.

This categories of computer is faster and more expensive which is capable of processing at least 10m arithmetic operations per second. Due to advances in technology of the mid 1980's super computers were designed for use in seismic data processing in oil explorations, nuclear explosion and so on.

ii. Main frame computer.

Is a large computer commonly advocated for in business and industry as it support network of multiple users and functions. Also expensive, large memory capacity and powerful in solving highly sophisticated problems.

iii. Mini Computer. A mini computer has same feature as main frames but lower in price, memory capacity and slower in processing data. It is easy to instal as it support network of user terminal or workstations,

iv. Micro Computer.

Is a general purpose computer found mostly in schools, Homes and small business organisations often referred to as pc, or desktop computer. It is less expensive with smaller memory capacity and processing speed. A micro computer is the most popularly

C H A P T E R T W O

(SYSTEM INVESTIGATION AND ANALYSIS)

2.0 INTRODUCTION

System study is a micro system analysis and design which calls for proper investigation in terms of alternative options and analysis of the cost benefit of each alternative. Investigation is carried out to avoid wastage in time, money and other available resources. The terminal end of feasibility study marks the beginning of detailed system analysis.

2.1 PROBRLEM INDENTIFICATION.

It is pertinent to observe that problems associated with the ownership of land are still more rampant in our society due to the importance attached. The author personally viewed that the following problems are inherent in the procedures for allocation. Some of the procedures include:

- i. A lot of time is wasted in retrieving files/records on previous transactions.
- ii. Files are often misplaced or lost;
- iii. Easy to manipulate.

Land speculators may collude with state officials to defraud government of his land or unsuspecting customer/land owner.

- iv. Record on mortgaged properties are not kept properly as many landowners use one Certificate of Occupancy for more than one mortgage deals.

In the light of the above, computerisation of the department was proposed.

2.2 FEASIBILITY STUDY (INVESTIGATION)

Feasibility study is a means of completely and effectively overhauling of an entire organisation, though management need to be adequately informed as its costly and time consuming.

Lucas, H.C (1985) in his book; says whatever the specific reasons for a new system in every instance, there is some dissatisfaction with the present

procedures or there would be no need for a new system.

Either current or expected demand for information processing cannot be met, so that some new system is needed. In any system development feasibility study is being accorded high priority so as to blend idea about operation of the existing system with regards to personnel, equipment available, procedures and problems associated with the success or otherwise of the organisation.

The outcome of such determines whether to go for detail analysis or abandon the project which has impact on the organisation to either belt-up the operations or be assured of maximising profits.

For project feasibility study objectives to be accomplished, it is noteworthy the project request is understood by the management and staff. At the prevailing circumstances, almost all the procedures are manually performed. It is hoped that the proposed computer system will provide the following:

- i. Provide an improved services to customers and users.
- ii. Overall operation efficiency by making possible speedy action on management decision.
- iii. Reduce to minimum those areas of conflicting or overlapping responsibility; and
- iv. Increase the speed and accuracy in processing data and report generation.

2.3 FACT FINDING METHOD

There are several means of collecting information with respect to any system. These may include sampling, questionnaire, interviewing, special purpose records, record search and observation. In the course of preparing this write up, the following were used.

a). Interview.

As a matter of fact, interviewing serves as the most common and reliable means of collecting/obtaining data. The author has the privilege to discuss with the

Director of lands and members of staff in the department. The outcome was indeed revealing.

Record Search.

Relevant forms used in processing for allocation of plot were issued to me for the purpose of the research. Such are land form 1, TUD (TP)1 Annexure iv copy of GRANT, copy of C of D.

Observation.

Going through the organisational chart, it reveals that many officers are employed performing virtually the same work. A lot of man hour required is thus wasted as files moves from office to office which may cause delay in taking decision.

2.4 TESTING PROJECT FEASIBILITY

In order to fully examine the merit or demerit of feasibility study, certain test are conducted to testify whether or not the system is useful to the organisation.

a). Operational.

When the whole idea of automation was mooted, the management tremendously supported it, while the lower cadre of staff rejected the idea, due to the believe that computerisation creates unemployment. An agreement was reached that no worker shall be relieved of his post because of the proposed computerisation scheme.

b). Technical.

The department has nothing with regard to existing automated equipment. A multimedia personal computer may however be adequate for now. Expansion may be thought of, in the near future.

As for the personnel, the department is blessed with high calibre of staff which might require short period to train them before automation commences.

c). Economic.

From the above, it is understood the department has to purchase virtually everything needed. Hardware, software and human ware. The cost of effectively carrying out this project at the initial stage will be

enormous but not out of the reach of the department. The system when installed, is expected to pay off the huge investment over a short period of time from the proceeds of its transactions.

However, a gradual phased reduction of personnel will be attained as lesser amount will now be spent on training and retraining of large pool staff that is currently being maintained and of stationaries.

2.5 OPERATIONAL PROCEDURE OF THE CURRENT SYSTEM (ANALYSIS)

Any applicant who may wish to own plot(s) in any part of the state has no problem in as much as it is online with the enabling law ie. land use decree of 1978. Each state has its peculiar way of processing, Niger State is not exception.

In a government approved layout, as well as any form of land, the procedures are the same but additional informations may be required where necessary.

Layout:

Purchase of form and answer all the questions. LAND FORM 1 Return the form to land Registry for processing with

- 2 file jackets with tags.
- 2 Recent passport photographs.
- 2 photo copies of three (3) years tax clearance.
- 2 photo copies of receipt of payment for purchase of form and processing.

For customary title hold, the following additional requirements are added:

Evidence of purchase letter of agreement duly signed by the family/community/village/town/district head with witnesses. Evidence from the Local government chairman of the area concerned or Local Government Right of Occupancy.

Any other relevant document that may facilitate easy processing

Those that fall under commercial, industrial educational

mining or agricultural purpose further include these evidence:

Certificate of company incorporation,
Minutes of the board of Director or share holders,
Relevant appropriate ministry approval eg. education, mining commence industry or agriculture.

The cost of application form and processing fee differs from an individual that apply for residential or commercial purpose.

By the time these conditions are fulfilled, the file leaves land registry to the table of Director of Lands or chief Land officer. He then minute to surveyor general to furnish the department with survey report as to whether the area is vacant or not; to give correct description and provide appropriate land area. (For government approved layout, no further survey since it has been carried out earlier). At the completion of the assignment, the file is returned to Director of lands.

From there, the file is passed to Town Planning Department for comment. They will advice on whether the purpose is suitable or not advance reason for none suitability. If the area applied for is not on government approved layout, from LUD(TP)1 ANNEXTURE(IV) is attached for Town Planning report by a registered Town Planner. In the and, the file goes back to the Director of Lands.

At this junction, file moves to the Director General for comment and then to the honourable commissioner to sign the Grant/Regrant of a Right of Occupancy.

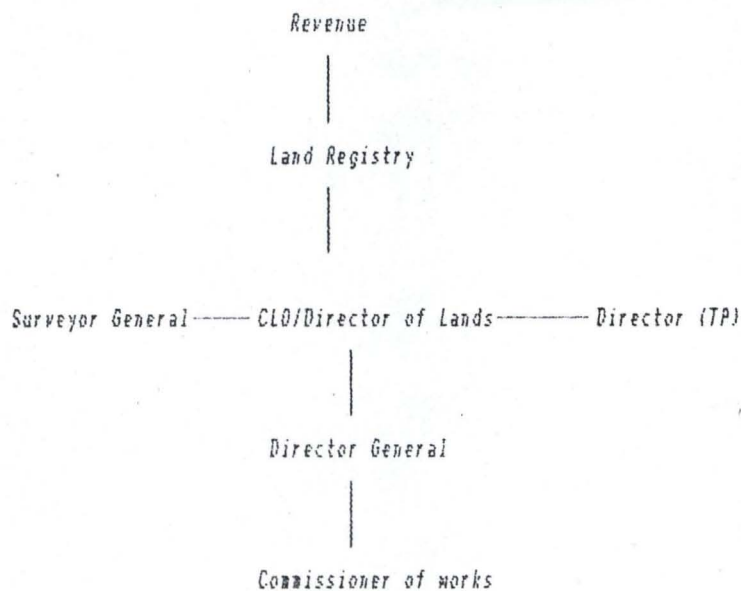


Fig 2. File movement for grant (R of O)

From the point of accepting the terms and conditions of the grant, you may commence processing for certificate of occupancy using Land form 12'B'. The Deed Registrar as earlier stated is concerned with the certificate of occupancy. He prepares the initial bills for payment with receipt in the Revenue section. The file leaves land registry from Director of lands table to the surveyor General to prepare title deed plan and prepare the sheet of map covering the area of the land. With this documents included, the file is passed to the Director General and Honourable Commissioner for their comments respectively.

The files are finally forward to the Governor for his signature and seal.

The title deed plan contains the following informations:

NGS No. for the plot

Name of the applicant and the LGA where the plot is situated surveyor General's signature and date bearing and distances.

Name and signatures of the officials that prepare

and approve the plan, sheet number, scale and the North Arrow.

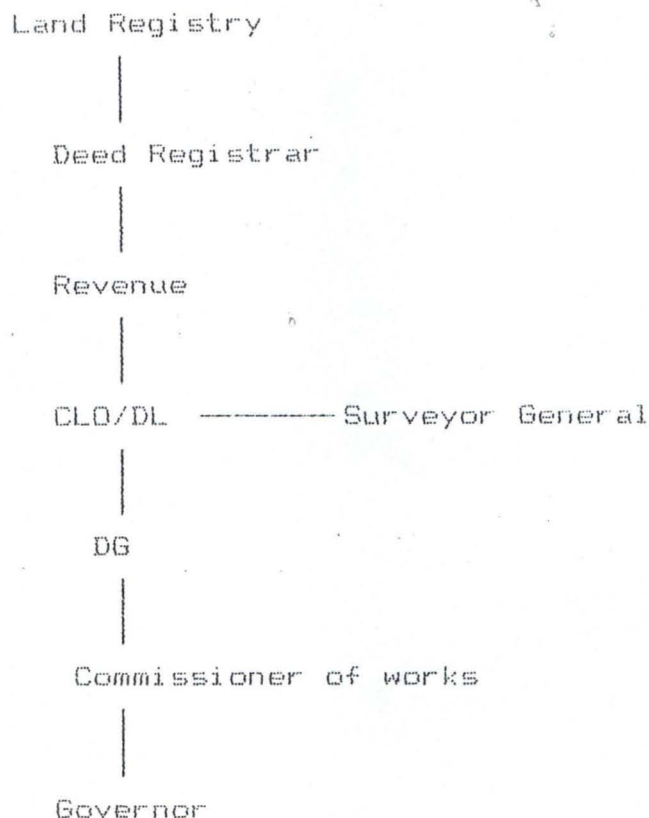


Fig.3 File movement for C of O

An applicant can consent to mortgage/Assign/Transfer/Sub. the plot given to him with the permission of land department. There is an appropriate form for such exercise.

Finally, to reduce the problems associated with land, area estate offices are situated in Bida, Suleja, New Bussa and Kontagora and each application is classified as per the area office it originate.

2.6 FINAL STUDIES AND RECOMMENDATION.

According to land use decree of 1978, it is not lawful for an individual or group below the stipulated age of twenty one (21) years to be granted a statutory right of occupancy or consent to the assignment or subletting of a statutory right of occupancy by the military Governor.

The feasibility study reveals the need for computer based system to match the current and future growth requirement of the organisation. The management was made to understand, the state nearness to the nation's federal capital. This has already introduce competetion inreal estate development in the state especially around Minna and Suleja.

The management accept the report to convert the existing procedures (system) to a computer based system following these criteria;

- a. There shall be a gradual process of reducing the staff.
- b. That a parallel changer over method of the current and proposed system be undertaken,
- c. Due to constraint of fund generally, only few staff at a time shall sent for training and as soon as possible a budgetry allocation for purchase of a personal computer will be made.

2.7 FEATURES OF PROPOSED SYSTEM.

The proposed computer based system will be design to take into consideration all the weak point of the current system presently in use.

As such, it is believed that the proposed system will ensure:-

- a). Minimize the level of manipulation by the rich end powerful,
- b).Due to volume of data generated, efficiency in the level of processing data is enhanced using computer,
- c). Report generation comes very fast either on the screen or hand copy (print) or both,
- d). If expected growth is achieved, enquiries will be made easily available over a short time,
- e). There shall be checks and balances on the part of landowners, mortgage institution so as to prevent fradulentuse of Certificate of Occupancy for double deals.

2.8 COST BENEFIT ANALYSIS

Gordon B.D and Mongrette H.O. opined that project do not all have the same cost benefits ratio. Some have a high economic value with other possess low pay off if successful. Bearing this in mind, land department is not an exception.

The cost of procuring software, as well as installation of hardware, other components and stationeries are all within the reach of the department.

With computerised system in place, there are high benefits to be derived which should be not over emphasised. Almost all th routines will be automatic e.g thereby saved time reduces the degree of mistakes or misplacement of files and improves efficient management decision making process.

CHAPTER THREE (SYSTEM DESIGN)

3.0 INTRODUCTION

As a result of careful system investigation and analysis being carried out, system design commenced. The analysis of the current problem is used at the beginning to develop objectives for the proposed system. This may lead to a number of possible alternative design as different combinations of manual and computerised elements may be considered.

3.1 MENU DESIGN.

The proposed system will be menu driven which is a selection process to perform relatively simple task such as centering a line or inserting a word. On the screen, there will be display of options for any task one may wish to undertake. The options may include add program, Edit text retrieve a file, print a report and exit.

3.2 OUTPUT SPECIFICATION.

It is important to develop a firm understanding of the information the system will provide to its users and the management. The design of the proposed system begins with the definitions of the outputs that will be generated which comes in two ways. The hand copy (print) or the screen. Due to sensitive nature surrounding land, both form of output will be essentially required.

The expected output are:-

Grant/Regrant of Right of Occupancy,

Certificate of Occupancy,

List of ground rent defaulters,

List of plot revoked/not developed according to plan.

3.3 INPUT SPECIFICATION

The design of input and file formats begins with the definition of the information to appear on the system's output (visual or hard copy). The record sizes for each file of the system will be determined.

Each field is designed to accept certain category of character (string, numeric, alphanumeric logical or dates). As mentioned earlier, some of the forms used in the existing system may be required to enhance the new system. They need not to be discarded completely except where necessary.

To reduce processing error, some of the field has to be coded.

3.4.1 DEFINITION OF TERMS

C OF O: Certificate of Occupancy is a Legal paper given out after due processess have been completed over apiece or percel of land. It is usually signed by the Governor.

R OF O: Right of Occupancy is a legal paper issue out after due process has been completed over a piece or parcel of land usually signed by the Honourable Commissioner of Works.

3.4.2 FLOWCHART

Programflow chart is a pictorial representation of a system prepared on the basis of symbols and relational flow lines. The term is used to indicate any type of diagram showing the sequence of events or action in the system. It is also known as computer procedure flowchart, and are often prepared as a preliminary to program coding to assist correct sequence of statements required. Program flowchart also show input operations setting of counter testing of counter, and loop or branching.

4.1 INTRODUCTION

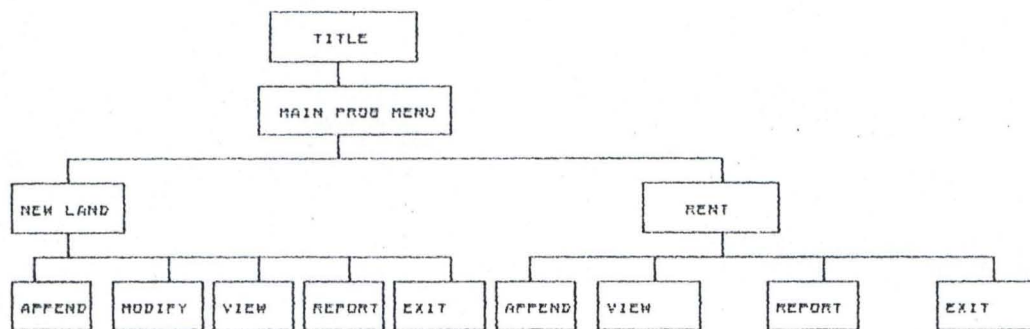
The databse approach is made operational by a database management system (DBMS), a software system which perform the functions of defining, creating, revising, and controlling the database.

4.3 MODULAR PROGRAM STRUCTURE

All program in this project work is structured in modules to ascertain the sequence in which the system works and to show relationship between processes.

With a personal computer, an operating system is used to boot the system before going into the environment. This can be achieved by either installing the program on the harddisk or through the use of floppy diskette. (3.5 or 5.25 sizes).



4.4 WORK STATION REQUIREMENT

This particular organisation in question is adopting computerisation for the first time as earlier mentioned in the feasibility study. Effort should be directed towards a work station or personal computer. This may however be improved upon with time and availability of resources.

4.5 IMPLEMENTATION

At this level of computerisation, it is ideal to implement the new system so developed. Hence, all aspect of the proposed system must be seen to meet operational standard prior to its being tested and subsequent usage. Newly designed forms are tested to check their efficiency, effectiveness and where necessary redesigned.

4.5.1 TRAINING

The operational staff for the proposed system are accorded the opportunity to be trained during installation and test run. This aspect of implementation is very important as these staff would in the end manned the system. They are however urged to repeatedly process the test data, often until they mastered all facets of the system.

A little technical knowledge of the system shall be

taught the operators, should in case the system abruptly malfunctions. This will save some cost of constantly seeking the analysis to always come for assistance; who may not be necessarily residing around the working environment of the organisation. As a matter of fact, the training shall be on the job to ensure perfections.

4.5.2 CONVERSION

As approved by the management, a parallel changeover or run will be preferred. Using a test data, the existing and the proposed systems run concurrently by processing exactly the same data. The result of the systems should be identical if the proposed system has been properly implemented. The conversion method adopted should be allowed to perform for one processing cycle.

To maintain dual system, seem to be expensive but its merit far outweigh the demerits as there is no data lost incase the system fails. Conversion however, encompasses site preparation and equipment installation.

4.5.3 POST IMPLEMENTATION REVIEW

Every aspect of the proposed system is checked and verified to ensure the operational accuracy as projected during analysis and design stage. A corrective measure are taken where necessary. An additional task of adequately maintaining the hardware and software must be put in place. Routine checking or servicing must be undertaken as at when due. Only qualified specialist are called upon to carry out repairs.

Always maintain an array of backup for any work done.

CHAPTER FIVE

(DOCUMENTATION SUMMARY & RECOMMENDATION)

5.1 DOCUMENTATION:

System documentation is necessary to keep management abreast of the current developments and to explain the working of the system to users.

The final reports covering the entire newly designed system must be documented indicating every aspect of its operations. An operating system PC-DOS, MS-DOS or window 95 is essential to start-up the personal computer. The application program is then installed on the hard disk or loaded from floppy diskettes 3.5inch. or 5.25inch. each time when required.

For security of the software to be maintained from unauthorised users gaining access, the package has a built in security system called PASSWORD. Only the operators has the knowledge and until such is entered, the system cannot be used.

Since the software is a menu driven, options are inputted in a form of one way entry and exit into the system. Once the range of selection has been exhausted, one can exit to DOS to perform other task or switch off the computer.

5.2 SUMMARY:

To sum up, attempt have been made to introduce a computerised system so as to keep abreast with the current trend of development universally. Land has been source of

worry or conflict to many people both rich and poor.

Having put in place a computerised system, the need to process application forms not only for efficiency but also to safeguard the precious nature's gift that this nation is endowed with abundantly.

The system is expected to pay off huge investment expended. These are sources from application and processing fee, ground rent and payment for bills in

respect of Certificate of Occupancy. The issue of ground rent defaulter can be put rest as list of them can easily be made available.

5.3 RECOMMENDATION:

In concluding this project, I wish to make the following recommendation.

(a). There should be a general re-organisation of the whole ministry and of particular interest the department of land. There are too many hands performing same or similar work. This is not always the case in private establishment.

(b). A qualified surveyor and Town Planning personnel be recruited by the department so as to eliminate the degree of dependence and reduce administrative bottle necks.

(c). A phrase staff reduction should be undertaken with utmost care.

(d). Effort must be geared toward ensuring that all mortgage deals which reflect the use of land as collateral be communicate to the department to check double deal.

(e). All fee due to the government shall be payable at a designated bank to reduce degree of fraud.

(f). A program of encouraging citizen to own personal houses should be introduced either by loan or owner occupier basis. Primary mortgage Institutions could be of great assistant in this direction.

(g). As time goes, the effect of computer system be spread to area offices to enhance their performances.
