ABSTRACT

This project is aimed at transforming the manual of keeping and processing academic record within Post Graduate Programmes in Federal University of Technology, Minna into a Computerised system to ease and quicken necessary operations. Mathematics / Computer Science Department is chosen as a base or case study.

With the System (A.I.S) in place, vital academic information like academic staff records with their bio- data, students' personal records with their bio-data, students' semester reports, students' transcripts, a summarized students' records for all the students - both part time and full time can be generated on demand from the database.

Also, staff / students' exit from the institution can be updated, Post graduation records i.e. keeping with the institution tracks of a student achievement in the larger society can be kept and monitored by the department.

Hence, inherent delays, burden and cost attributed to the manual mode of keeping and processing academic information will be maximally handled with the Academic Information System (A.I.S) in place.

CHAPTER ONE

1.0 GENERAL INTRODUCTION

This study is on Academic Information System (AIS), which incorporates all Departments in the Federal University of Technology, Minna-Niger State.

It is obvious that, to meet up with the challenges of our time in terms of data storage, speed and ease of operations, a computerized system for an organized body like F.U.T, Minna is needed. Hence, the idea of AIS is borne to generate a system that will handle the following Academic Information with relative ease, speed and accuracy. These areas include:

- * Academic staff records with their Bio-data.
- Departments and courses offered.
- * Semester Records Involving course allocation for each lecturer.
- Students record involving
 - Their Bio-Data.
 - Courses Registered Per Semester.
 - Examination Records.
- Staff/Students exit i.e the system should have room for updating the exit of a staff or student from the institution.

* Post Graduation Records i.e keeping with the institution tracts of a student's achievement in the larger society. It is worth noting that with the AIS in place within the institution, problems of manual processing and generating reports by examination officers and others, concerned with academic information will be maximally handled. Hence, reports on Academic Staff Information, enquiries on the Department about courses offered, students' personal examination records like semester results and transcripts, updating staff/students records, etc can easily be generated to meet up with the required operational speed within the university.

1.1 BRIEF HISTORICAL BACKGROUND OF FEDERAL UNIVERSITY OF TECHNOLOGY MINNA.

The Federal University of Technology Minna is a Federal University established on 1st February 1983. The basic objective is to achieve the drive for self-reliance in science, Engineering and Technology.

The foundation Vice-chancellor from 1983-1990 was Professor J. O. Ndagi who later handed over to Professor S.O Adeyemi as a Vice chancellor from 1990-1994. Professor I. H Umar was the Sole Adminitrator1994-1997, Professor S. A Garba was appointed as the Acting Vice-Chancellor on 26th June 1997. From 7th August 1997 till date, Professor M.A Daniyan is the Vice Chancellor. Amongst those that served as Registrars are: Dr B. P Sawa from 1983-1986, Mrs L. S. T Ahmed 1988-1993 while the current Registrar is Alhaji U. A Sadiq who was appointed as substantive Registrar with effect from October 1998 after acting in that position since 1993.

Presently the university is located within Bosso Area of Minna as Bosso campus and work started on the main campus along Minna-Kataeregi-Bida Road since Teusday, June 22nd 1992 after the foundation laying by General Ibrahim Badamasi Babangida .

So far, eight sets of students has graduated from the university and the total students enrolment is now about 5, 138 with academic staff of about 250.

1.2 SERVICES/ACTIVITIES OF THE UNIVERSITY


The university offers the following services to a wide range of students and staff alike.

- (i) Health services.
- (ii) Library services.
- (iii) Consultancy services.
- (iv) Works and Maintenance services.
- (v) An operational computer centre.
- (vi) Audio visuals centre with the following units namely:
 - Graphic/Visual aids Unit.
 - Photographic and Lamination Unit.
 - Audio/reproduction unit.
 - F Instructional Technology Unit.

1.3 ADMINISTRATIVE STRUCTURE (ORGANOGRAM) OF THE UNIVERSITY

1.4 FUNCTIONS OF DIVISIONS AND UNITS

Various tasks are shared and grouped into divisions and units with the major aim of enhancing smooth running of the University through a co-ordinated effort from the various parts that make up the system

1.5 BREAKDOWN OF ACADEMIC AFFAIRS

Federal University of Technology, Minna is organized into five academic Units Known as schools, namely:

- (i) School of Science & Science Education (S.S.S.E).
- (ii) School of Environmental Technology (S.E.T).
- (iii) School of Engineering and Engineering Technology (S.E.E.T).
- (iv) School of Agriculture & Agricultural Technology (S.A.A.T)
- (v) Post Graduate School (PGS)

The head of each school is the DEAN who work hand in hand with an administrative head called School Secretary for the coordination of the school. The school secretary represent the Registrar at the school level. Each department under a school has its own Head called HEAD OF DEPARTMENT (H.O.D). There is also the Course Co-ordinator/Examination Officers who help the H.O.D(s) in the running of the Departments. The lecturers fall under the course coordinator and finally, the students are under the lecturers.

Note that courses offered by the various Departments leads to the awards of B. Tech Degrees (After 4 or 5 years). An exception is the school of Eng. & Engineering Technology that awards B. Eng (Hons) Degrees and Post graduates school awards a higher degree i.e Post Graduate Diploma (PGD) in the chosen field of study. Normally, the PGD programme lasts for one year or two years for full time or part time respectively. The various courses are offered on a sessional basis and each session is broken into 2 semesters that last for at least 4 months for each semester.

Further breakdown of the courses under the various schools are as shown in the diagram below.




Fig. 2: BREAKDOWN OF SCHOOLS AND COURSES

POST GRADUATE SCHOOL

This school awards Post Graduate Diploma in the following disciplines:

(i) Computer Science.

(ii) Educational Technology.

(iii) Mechanical Engineering.

(iv) Chemical Engineering.

(v) Agricultural Engineering.

(vi) Environmental Technology.

(vii) Soil Science.

(viii) Project management.

(ix) Landscape Architecture.

<u>NOTE</u>: The PG-School co-ordinates the award of masters degree and the Doctorate degrees (Ph.D). The PGD, Masters and Doctorate programmes are either on full time or part-time. For this project work, the scope shall be the Post Graduate programmes. Masters and Doctorate programmes shall not be involved so as to give room for full treatment of the chosen scope.

1.6 OBJECTIVES OF THE STUDY

- To transform the manual mode of keeping and processing Academic records in the institution into a computerized system, to ease the operations within the institution.
- (ii) To be able to see at the click of a button, all Academic Staff
 Information on BioData, qualification, Job experience, etc.
- (iii) To be able to inquire on the departments and courses offered.
- (iv) To be able to view or print any information about any student in the area of:

- Personal Records

- Examination Records.

(v) To be able to produce Academic Transcripts of students on demand from the database.

(vi) To be able to update both students and staff records with new information.

(vii) To be able to monitor graduated students, keeping tracks of their achievements in the larger society.

1.7. SCOPE OF THE STUDY

This project work is focused on all academic data from departments, Schools and the registry (MIS). The data for the project are obtained from the Registry, the departments and Schools of the university. It is to be understood that the structure being designed is applicable and adaptable to all departments at the post Graduate level since they generate the same type of data and information.

However, for the limited time available for this project to be developed, the volume of work involved, the designed system is limited to the Mathematics/Computer Science Department under the school of Science and Science Education in the Post Graduate School. The design is the basis or insight with which similar systems can be designed for all the departments in the various schools.

CHAPTER TWO

REVIEW OF LITERATURES

2.1 DEFINITION OF TERMS

Relevant terms used in the project are defined as follows:

- a. COMPUTER: This is an electronic device, which stores information on discs or magnetic tapes, analyses it and produces information as required from the data on the discs or tapes. Defined in another way, computer is an electronic machine that can receive instruction through input, process the instructions and produce meaningful results.
- b. HARDWARE: These are the physical components of a computer which we can touch e.g. keyboard, system unit, mouse, printer, the Visual Display Unit (VDU), etc.
- c. SOFTWARE: These are set of instructions that direct the computer on what to do to perform a specific task.
- d. TABLE: A set of information about a particular subject. For Example, a table can contain information on the courses offered by a department.
- e. RECORDS: A record is made up of fields, which contain specific information about what the record represents.
- f. FIELD: This holds one piece of information and it is the smallest component or part in a database.

- g. KEY FIELD: This is a unique identifier within a record.
- h. QUERY: This is a method used to manipulate information in tables of a database. Such manipulations include sorting, calculating, extracting records that satisfy certain criteria. There are of two types, namely:

SELECT QUERIES used to manipulate information, but information in the database cannot be changed with it. UPDATE QUERIES used to add, remove or modify the information in the database tables.

- i. FORMS: These are used to ease the data entry work of getting information into the tables of the database.
- j. CONTROLS: A form is made up of controls. A control is used to facilitate the entry of information into the table(s) that the form represents. Usually, there are text boxes and free standing text assembled in the design on-screen which is easy to modify if it does not meet user's requirement.
- k. REPORT: Used to present the information in the database in an organized fashion, which can be printed out on paper (i.e. hardcopy).
- MACROS: These are named collections of keystrokes and menu choices that can be run just by referring to the macro's name.

m. DATA: This simply means, unstructured facts.

 n. INFORMATION: Data, facts that has been structured or processed generates information.

2.2 COMPUTERISED STUDENT'S PERSONAL/EXAM RECORDS

A project to handle the student's personal/exam records had been handled by students prior to this time, but the scope is limited to the undergraduate alone and staff records was not given consideration in the designed system. Such projects include:

- Computerised Student's Record (A case study of Mechanical Engineering Dept; Federal University of Technology, Minna)
 By Solomon Ikono Umoinyang, March 1994.
- Computerized Students Records (A case study of Mathematics/Computer Science Department, Federal University of Technology, Minna) By Fatima I. Yusuf, 1996 (PGD/MCS/032).
- Computerization of students Exam Records (A case study of Mathematics/Computer Science Department; FUT, Minna) by Adekola A. Tokunbo, 1996.

The overall objectives of these projects were to investigate the existing system in the department as at their time so as to:

(i) Improve students' record keeping in the departments.

(ii) To improve accuracy of students' record keeping.

(iii) To minimize processing time of students' results.

(iv) To generate students' semester reports at the departmental level and for presentation to the senate.

From enquiry made from departments, there is no functional computer based recording and processing of staff records, students' personal and exam records. To some extent, the Mathematics/Computer Science Department has a functional computer based record system that handle result processing for the undergraduates, but there is none for the postgraduate students.

Hence, the adoption of the proposed Academic information system (AIS) at the POST GRADUATE level to handle both students and staff records will go a long way to minimize inherent delays and burden in handling of records in the departments. The AIS has features that is applicable to all departments so, there is no limitation to its adoption.

2.3 DATABASE MANAGEMENT SYSTEM (DBMS)

A Database Management System (DBMS) is a collection of programmes, which stores, retrieves and processes data stored in

files. It is a unified integrated model for managing files stored in Computer storage devices and it gives room for easy editing and retrieval of the stored information. DBMS is possible through the use of database software like Microsoft Access, Microsoft FoxPro, Borland Dbase and Lotus Approach, etc. The DBMS serve as the interface between the users and the database. When users wants to access the database, users requests are directed to the DBMS which passes the requests to the Accesses, the Accesses go to the database and activate the required data into an organized form and then relay the information back to DBMS to add the correct level of details before the output is displayed to the user. The DBMS works hand in hand with the chosen programming language (Microsoft Visual FoxPro) used in the system development.

2.3.1 DATA BASE

A DATABASE is a collection of information related to a particular subject, stored and organized in a specific order. On the other hand, a database is a collection of tables, queries, forms, reports, etc that stores information about a related subject. Example of database include: music collection or video cassette collections, students' record files, hospital records, telephone directory, library catalogue scheme, e.t.c. One basic feature of databases is that there is a clearly defined order of arranging the information in a database for example to locate a student's file from a department, his/her registration number or file number must be known. It is with the registration number that his/her file will be searched for and located. Hence, the definite order of arranging records makes it easy to locate the needed information with ease. It is to be noted that the databases obtainable in the university i.e F.U.T minna are generally MANUAL DATABASE except at the management information system (MIS) unit that management information are stored with computers. Databases stored in manual form (i.e on paper, forms, books) are MANUAL DATEBASE, but databases stored with the computer are referred to as ELECTRONIC DATABASE. The proposed academic information system (AIS), which is an electronic database, will go a long way to handle the inherent problems with the existing manual system. Such advantages we can attribute to the proposed AIS can be seen in **3.3.3** of chapter three.

2.4 MANAGEMENT INFORMATION SYSTEM (MIS)

Management information system is an organized information network using computer capabilities to provide management with vital information needed for decision making. MIS is of vital need

to managers at any level because information generated from the information system support or enhances their decision. All MIS has the following basic features;

(i) It must have outlet for expansion i.e being flexible to handle organisation's changing needs.

(ii) Must store and generate results needed by users.

(iii) Must generate reports whose information are correct, timely, complete and straightforward.

MIS HAS THE FOLLOWING SPECIALISED SUB SYSTEM

- (i) Management Support System (MSS): This system provides concise timely and regular reports needed by managers in making effective decision. Information from MSS is a vital tool for all managerial decisions.
- (ii) Decision Support System (DSS): Information from DSS aids upper level decision makers by combining data with models and graphics to answer a decision maker's question about the data.
- (iii) Functional Information System (FIS): Every set up has its own functional areas like marketing unit, manufacturing unit, personnel unit, accounting unit, etc. An information

system that carryout operation in the various functional areas within an organisation is called the FIS.

- (iv) Office Information System (OIS): This is a machine or machines combined with communication system and users to enhance the task of obtaining, organizing, storing and retrieving data.
- (v) Expert System (ES): It is a programmed computer system to be like human specialist in a field to advice, diagnose, and behave in a pre-designed way. On another way round, an expert system is an organized collection of people, procedures, database, devices, etc used to generate expert advice or suggest a decision in an area or discipline. It is to be noted however, that the use of ES has not fully gained ground in our setting except in developed countries that the use is more.

2.4.1 ACADEMIC INFORMATION SYSTEM (AIS)

The AIS like the MIS and some of its sub system is a database that stores relevant or vital academic records needed at all level within the institution. It gives room for expansion and editing of its content and has other features in common with the MIS.

CHAPTER THREE

3.1.0 SYSTEM ANALYSIS AND DESIGN (SAD)

A system is an organized collection of interrelated elements that work together for a defined common goal. Put in another way, a system is an orderly and interconnected complex arrangement of parts for a common goal.

System Analysis and Design is a problem solving activity that involves a critical examination of a system, identification of function and devising improvements. The process of SAD is in 5 stages which are:

SYSTEM INVESTIGATION: This involves problem definition, identifying the information needs of a system and the feasibility of meeting these needs.

SYSTEM ANALYSIS: This involves a detailed study of the current system including procedures, information flows and methods of work organisation and control.

SYSTEM DESIGN: This involves devising an alternative information system using the current problems analysed as the beginning of system design to develop objectives for the proposed system.

SYSTEM DEVELOPMENT AND IMPLEMENTATION: This involves the acquisition of hardware/software or writing the needed software, testing and training of the end users of the system.

SYSTEM MAINTENANCE: This entails monitoring and evaluating the new information system and making necessary changes as applicable.

3.1.1 SYSTEM INVESTIGATION

The task at hand is to transform the manual mode of keeping and processing Academic records in the institution into a computerized system to ease the operations and remove the burden and delays in processing Academic Records.

On investigation, the problem is such that affect the entire academic system within F.U.T, Minna, but the scope of data coverage for this project is limited to the Post Graduate School, reasons being that the systems developed thus far by students to solve the inherent problem under discourse focused just on the undergraduate. Therefore, this AIS is to find solution to the problem at postgraduate level to avoid duplication of work.

3.1.2 FEASIBILITY STUDY

From the search and enquiry carried out, the possibility of the use of the proposed AIS can be grouped under the following headings:

- (i) Technical Feasibility: The university with its various departments has in place most of the computer hardware components and software that the new system will need. The specialist or lecturers with detailed knowledge of computer operations are also available and additional systems support personnel can be trained in house to use the system being developed.
- (ii) Operational Feasibility: The users of the new system namely

 the H.O.D's, the exam officers, lecturers, secretaries, etc are engaged with much work which the coming of the new system of operation will greatly enhance their work and lessen the stress they go through in storing and processing records. Training of users without the knowledge of operating the new system is a task that can be handled through orientation.
- (iii) Economic Feasibility: The cost in implementing the new system cannot in any way be compared with the better users satisfaction like speed of processing records, good storage

system, less stress, easy management of vast records for many students, etc.

3.2.0 SYSTEM ANALYSIS

A detailed and careful study of the existing system shows that each course offered at the Post Graduate School (PGS) is under the control of the respective H.O.Ds. Hence, the lecturers for each course reports back to the exam officer.


Each lecturer prepares result sheet mainly according to the format seen in appendix A and submit the result sheet to the exam officer for consideration and approval after which the exam officer/course coordinator prepares a report according to the format seen in Appendix B entering and calculating the CGPA of each student manually and then prepares the cumulative students exam record sheet as in appendix C and presents to the H.O.D. and that is the format taken to the Dean of school and finally to the senate committee for approval.

The exam officers in turn reports to the H.O.D. of respective department, the Head of Departments then report to the Dean of their respective schools. The Dean is answerable to the Senate Committee.

The information flow can be simplified in the flow diagram below:



The lecturers teach the students for at most 4 months per semester for 2 semesters within which class assessment (CA) are done in the form of tests, assignments, term paper, e. t. c, after which exams are conducted. The sum of the CA score and Exam score form the total score and the grade allotted to each score fall within the grading system below;

PERSONAL RECORDS

Records about each student involving their particulars, courses registered, e.t.c are entered on forms by individual students which are then filed and kept with the course co-ordinators. Similarly, information about staffs are entered on forms, filed and kept with the H.O.D.

Information retrieval about any student or staff is by tracing their respective file and accessing the required record.

DATA GATHERING

All the vital data, forms and their formats used in this project were arrived at through the following tools;

(i) INTERVIEW; In order to get a detailed and up to date information about the PGS academic records, the examination officer/course co-ordinator was interviewed and he gave the briefing on how the system operates, description of the exact format of the required forms e.g. lecturer's result sheet, type of records kept about staff, etc. This was done so as not to deviate from the user is need.

- (ii) RECORD SEARCHING; Other vital information were gotten from records kept with secretaries at various department, the secretaries at various departments, the library, the management information unit (MIS) school hand books, e t c.
- (iii) OBSERVATION Some information were arrived at through observation of the system by the analyst having observed the methods of processing data, the time it takes for semester results to be released, e t c one was able to reach conclusion on some issues like the inefficiency of the existing system.

3.2.3 PROBLEMS/LIMITATION OF EXISTING SYSTEM

The investigation and thorough study of the existing system reveals that:

- Processing procedure is too tedious for the lecturers and the exam officers.
- (ii) Processing is too slow.

- (iii) Poor efficiency in the use of resources as much resources is wasted on paper work.
- (iv) Insecurity of vital information.
- (v) Poor feedback system.
- (vi) No organized information system.

3.3.0 SYSTEM DESIGN

The analysis of the existing problems is used as the basis for which objectives are developed for the proposed system. Hence, the overall need for the proposed Academic Information System (AIS) is to fully handle the problems analysed in **3.2.3** above.

The system is designed to handle the following needs:

- (i) Academic staff records with their Biodata.
- (ii) List of Departments and courses offered.
- (iii) Semester Records involving
 - Course allocation for each lecturer.
- (iv) Students Record involving
 - Their Biodata
 - Courses Registered per semester or for the session.
 - Examination Records.
- (v) Staff/Student's Exit i.e. the system has room for updating the exit of a staff or student from the institution.
- (vi) Post Graduation Records.

Other features in the designed system include:

- * Security device i.e. password.
- * Set up/backup facilities.
- * Update screen as appropriate
- * Enquiry Screen.
- * Exit Screen.

3.3.1 DATA ENTRY

Various screens are designed for input data relating to:

- (i) Staff employment records.
- (ii) Student's Registration records.
- (iii) Student's personal data.
- (iv) Departmental data records for students.
- (v) Class Assessment/Examination records entries.

3.3.2 PROCESSING

Processing shall cover:

- (i) Deducing student's scores and grades in each course.
- (ii) Calculation of GPA.
- (iii) Calculation of CGPA.

3.3.3 OUTPUTS

Queries can be made on any of the inputs as in **3.3.0** and **3.3.1** depending on which information is needed.

Majorly, the following reports can be generated from the designed system:

- (i) Student's Report Sheet format as in appendix A.
- (ii) Student's Transcript as in Appendix B.
- (iii) A Summarized or Cumulative Student's Exam Record as in Appendix C.
- (iv) Report about staff records as in Appendix D.
- (v) Reports about student's personal Records as in Appendix E.

NOTE: Each of the generated reports are as attached in the Appendices.

CHAPTER FOUR

4.0 SOFTWARE DEVELOPMENT

4.1 CHOICE OF PROGRAMMING LANGUAGE

The chosen programming language for the AIS is the Microsoft Visual FoxPro 6.0. Data for the proposed AIS is very voluminous and various manipulations like querying, reporting generation, etc are to be performed on the stored data. This will involve using database management software for its development.

4.2 FEATURES OF MICROSOFT VISUAL FOXPRO

Microsoft Visual FoxPro 6.0 is a database programming software, which has many features that will greatly enhance the AIS development, these features are:

- (i) It is an improvement on Dbase IV and it is one of the recent, well-established database applications that is useable with the windows operating system.
- (ii) It can build an executable file, which can be installed in any system running windows operating system not necessarily having the Microsoft Visual FoxPro built on it.
- (iii) It can contain as much as one billion records, a field in a table can contain about 258 characters and a table can contain 300 fields.

- (iv) It has a graphic user interface, which makes the logic of software development to be easily understood by users because program codes are written in modular structure.
- (v) It has built in data dictionary that has definition for tables;establish relationship between tables, etc.
- (vi) It has a general field in the table structure that can be used to call in files from other applications such as Microsoft Word, Microsoft Excel, and Graphics like pictures graphs and charts.

All the features mentioned above clearly shows that Microsoft Visual FoxPro would meet all the requirements needed for this project, hence its usage.

4.3 DESIGN OF A DATABASE AND TABLES

A database is a collection of related tables. A table is a structure designed to keep records. A record consists of rows of information and each column of the data or information is a field. The major tool used to organize and manage files and to create data fields, tables, queries, forms, reports, building applications is called

In creating a table, the data types used are specified. Data types used in Microsoft Visual FoxPro include:

- a. Character: This allows the entry of alphanumeric texts e.g. letters, numbers, spaces, symbols and punctuations.
- b. Numeric: The Numeric data type is used for digits or numbers which may be integers or fractions.
- c. Date: This accepts date entries of day, month and year.

d. Memo: Memo data type is used to store blocks of data mainly text.

In creating a table, the following steps are usually followed:

(i) From the Project Manager or the File menu, click on the
 New button and this activates the Table Designer and the
 New Table window opens.

From the 3 tabs -the field, indexes and table tabs,

- (i) Click on the field tab and type in the needed fields under the name column heading.
- (ii) Specify the data type under the type column heading.
- (iii) Type the width of the field under the width column (Note that the width is the maximum number of character spaces for each field.

(iv) Under the decimal column, indicate the number of decimal spaces.

INDEXING FIELDS

To index fields,

(i) Click on the Index tab.

(ii) Specify if index is ascending or descending.

Within the table designer above, fields can be formatted to taste under the FORMAT box. A desired input format can be given to the field with the INPUT MASK.

Default value is the value that is automatically displayed whenever a new record is added to a table. This can be specified under the **default value box.**

Appropriate rules guiding the entry of data for each field can be specified in the validation rules and message boxes.

If all these operations are performed, click the OK button. Other buttons like cancel, delete, save perform functions as indicated by their names.

INDEX KEY FIELDS

Index key fields can be indexed in three major ways :

- (i) Primary Index: This key is used to identify a field that uniquely identifies a record.
- (ii) Candidate Index: Any index or a field apart from the primary index that also uniquely identifies a record.
- (iii) **Regular Index:** An index that is not primary or candidate.

The individual entities identified in system analysis and design stages are organized into tables.

The following tables, which are the bedrock of the software of this project, are organized in a database named **AcademicRecords**. Table 1: qFullFirst.

4.4 DESIGN OF DATA ENTRY FORMS AND USER INTERFACES

Forms provide an interface to the user for viewing and entering data into a database easily with less time.

In this project, forms have been developed for the major tables in an attempt to build a clear, helpful and easy interface that are efficient and user friendly.

4.4.1 CREATING FORMS

The creation of forms within Visual Foxpro is done in the FORM DESIGNER which can be used in the designing and modifying forms. The diagram above shows a Form Designer and it's tool bars:

METHODS: Any of these steps can be followed to create a form:


- Select FORMS in the Project Manager and click on NEW button.
- (ii) Select the File Menu, click on FORM and then click on NEW FILE.

Type CREATE FORM on the command window and press enter key.

In building a form, fields are dragged from a table in the Form's Data environment and dropped on the form and adjusted as desired.

To activate the DATA ENVIRONMENT where fields are dragged to the form, click on the View Menu and click on Data Environment. The environment is displayed as above:

4.5 **DESIGN OF QUERIES**

To make information retrieval from the database easier and faster, queries can be designed any time to display certain aspect of the database based on certain criteria.

STEPS:

From the Project Manager, the query designer (shown below) is accessed as follows:

- (i) Select Queries under the ALL or DATA tab
- (ii) Click on NEW

command window, the query designer will be accessed.

A sampled Query performed on the database through program, to display desired information from the database are as attached in the appendice.

4.6 DESIGN OF REPORTS

Reports show a display of summarized data or information in a printed document. Amongst the reports that can be generated from the AIS are:

- (i) Student's Result Sheet.
- (ii) Student's Transcript for two semesters for full time students and three semesters for part-time students.
- (iii) A summarized or cumulative student's Exam Records for all the students.

(iv) Report about staff records.

(v) Report about student's personal records.

A sample of these reports (outputs) are as displayed in appendix A, B, C, D, E.

4.7 BUILDING THE PROJECT

The necessary components of the project are the tables, forms, queries, reports, menus and the database itself. These components are linked together by a main program that controls every other program. The main program is automatically built into an executable file which makes the main program executable in a computer either with Visual FoxPro installed or not. In a system that Visual FoxPro is not installed, the program becomes read only. That is, users cannot see the source code and modify in any way.

4.8. SYSTEM IMPLEMENTATION AND DOCUMENTATION

As part of the implementation of the new AIS, that is, carrying out a thorough test of the hardware components, the software and its procedures and to confirm that it works to specification meeting the user's need, the AIS shall be ran on the department's personal computer. The users that will operate the new system are to be fully involved in the test.

4.8.1. SYSTEM DOCUMENTATION

In providing a detail explanation of the workings of the AIS to aid the end user of the application, a documentary is written which is attached in the appendix.

4.8.2. TRAINING

As part of the implementation plan for the AIS, the major users of the system i.e. the exam officers, the course co-ordinators, lecturers, etc shall be involved in the orientation process before the eventual usage of the new system.

4.8.3. CHANGEOVER

- (i) Direct Changeover: This is the process of changing from the old information system to the new one at a go. One inherent disadvantange of this method is that it is highly risky incase of failure.
- (ii) Parallel Changeover: This process involves using the old and the new information system concurrently thereby using one as a check and balance on the other. It is less risky and it is very expensive to run.
- (iii) Pilot Changeover: The new information system is applied on a part or section of the organisation using old data to test the

operation of the new system and when it is proved to be okay, it is applied to the whole organisation.

(iv) Staged Changeover: This method involves introducing the new system to gradually replace the old system. This method is less risky and gives room for the analyst and users of the system to learn from mistakes.

For the purpose of this project, the PILOT CHANGEOVER is recommended. That is, using previous records and data to test the new AIS to deduce if the desired output is produced. If it works according to expectation, then its adoption is evident.

4.8.4. SYSTEM MAINTENANCE

A maintenance routine is necessary to monitor and evaluate the new system. The users of the new AIS should endeavour to check on the reliability, efficiency, targets and goals of the new information system being maintained in the course of using the new system. System review can be conducted periodically to make sure that all things are working to expectation.

CHAPTER FIVE

DISCUSSION OF RESULTS, RECOMMENDATION AND CONCLUSION

5.1. DISCUSSION OF RESULTS

Broadly speaking, in any system, speed of operation, accuracy and good performance with less effort is needed. With the computerization of the operations of keeping student's personal/exam records and other information needed about staff, work will be greatly enhanced with quick turnover. Hence, the need for having a computer based Academic Information System (AIS) as designed in this project cannot be over emphasized.

The output from the system are printed reports are as shown in the appendix A, B, C, D, E, F, respectively.

5.2. LIMITATION OF THE STUDY

The scope of the project is too wide if all schools and their departments are to be covered in this project. Therefore, for a start, the foundation has been laid using Mathematics/Computer Sc Department in the School Of Science and Science Education. Further researchers behind can build on this foundation years ahead to the stage that the whole schools and their departments are on network.

5.3. CONCLUSION

The goal of this project is to come up with a system that will aid keeping and processing of Academic records, and providing relevant academic information about students and staff which will aid decision at all levels. It is aimed that processing of these records will be done with ease, speed and accuracy using computers.

Hence, the computerization of Academic records within Mathematics/Computer Sc Department and the entire school at subsequent period is a drive for transformation to keep pace with the information need of our time thereby removing inherent delays, burdens and problems encountered with manual processing.

5.4. RECOMMENDATION

My Recommendations are as follows:

- (i) The operations of Academic records keeping in Mathematics/Computer Sc Department and the entire university be computerized.
- (ii) Principal Officers in the department (Head of Department,course coordinators, exam officers, the lectures, etc) should

have a personal computer at their disposal and maintain a well organized database and data structures so that data can be readily accessed and processed.

- (iii) The services of at least one system analyst and one programmer is needed either from amongst the lecturers or any other source so that the system can be closely monitored and relevant modification can be done from time to time.
- (iv) The backup of the new system should be constantly kept in case of any corruption of the copy on the personal computer.
- (v) All computer databases maintained by the principal officers should be interconnected to enhance exchange of data and information.
- (vi) Copying, deletion and modification of records should strictly be monitored by the database administrator (say the course coordinator/exam officer). This he can do by not allowing unauthorized users of the system through the use of the security device.
- (vii) The Scope of this project can be increased by further researchers to cover grounds not touched in this project.
 Effort should be geared towards maintaining a working computer based system and networking the entire system.
