ABSTRACT

The nature need and objectives of a computerised Geographic Information System as well as overview of GIS principles and major components are examined.

Issues concerning awareness and human and organisational problems. Software/Hardware configuration, cost and data capture availability and linkage are discussed in details. Database management system is highlighted. Other issues handled in the project include research and development, Co-ordination, Conceptual GIS is recommended with special references with problems in developing countries.

CHAPTER ONE

INTRODUCTION TO GEOGRAPHIC INFORMATION SYSTEM

1.1 INTRODUCTION.

The project covers activities in the department of land, planning and Surveys, for the production/retrieval of information about land allocated to individuals, private and government organisations within the Federal Capital Territory (FCT), thus many characteristics of various sizes and purposes of land allocation are taken into consideration in the design. Entry of input in the system is through the Keyboard and visual display Unit.

The GIS for land allocation is design to combine the advantages of the manuals and system as flexible and easy access to information and straight forward operation with improved accuracy, avoidance of duplication and better management information.

1.2 DEFINITION OF GEOGRAPHIC INFORMATION SYSTEM (GIS)

GIS is a computer system, which perform operation on spatial data, that is, data, which have positional references. GIS interest is the spatial data; it is therefore necessary to understand spatial data as geo reference data that have shape, size, dimension and physical form.

They represent features of our real world, maps and drawings, are historical spatial database. Spatial information has two major components namely:

- (1) Graphical;
- (2) Non Graphical

Graphical (or geometrical) information refers to the shape, size and length of features and how the features are spatially related to one another (Topology). Non graphical information on the other hand, refers to the attributes of a feature such as the name of a highway or the owner of a land parcel. Regardless of how the information is actually stored on the computer.

It is sometimes convenient to regard the database as being composed of the graphical database and the attributes, each of which is related to the other. A computer database containing predominantly spatial information is called a geographic information system. For this database to be of any use, a computer system must be built around it to allow for easy input analysis and display of information.

Spatial information is therefore the term that encompasses data and knowledge about the location and distribution of earth related entities.

These entities can be natural object such as trees, natural phenomenon such as precipitation or man made.

Object such as land parcel or man made phenomenon such as population densities. A spatial information system is used to create, maintain and to disseminate such information, it includes the organisational context, or structure that manage the system and procedures and tools, such as geographic information system GIS registered for systems operation.

1.3 ESTABLISHMENT OF FCDA

Federal capital Development Authority with acronym (FCDA) was
Established by decree No. 6 of 4th February'76 and has seven
departments namely;

- a. Department of Finance;
- b. Department of Administration and Personnel;
- c. Department of Health;
- d. Department of Land, Planing and Survey;
- e. Department of Agriculture;
- f. Department of Public works;
- g. Legal Department.

The department of interest in this project is the department of Land, Planing and Survey.

1.4 RESPONSIBILITIES AND STRUCTURE OF DEPARTMENT OF LPS.

Department of Land, Planing and survey is divided into three main Divisions namely;

- Land Division;
- Planing Division;
- Survey Division.

And the responsibilities of the department are as follows.

- a. Prepare a layout of land within the FCT;
- b. Carry out survey or demarcation of parcel of land;
- c. Allocate land to individuals, private and governmental organisation;
- d. Monitor the development of infrastructure within the FCT;
- e. Check illegal structure of development within the FCT;
- f. Advise the Resettlement Committee on the best methods for resettlement and payment of compensation to the displaced persons of the FCT;
- g. Approved building plans for the development within the FCT;

- h. Check illegal allocations and sales of Land by the village wards or heads within the FCT;
- i. Prepare and issue Certificate of Occupancy to the allottees of lands within the FCT;
- j. Check the mixed up in the allocation of land and advise the authority on the best methods of reallocation of the plots to the allottees.

1.5 AIMS AND OBJECTIVES OF THIS PROJECT.

The project treats the retrieval of information on the activities and allocation of plots within FCT and the objective of this project are:

- a. Development of Computerised methods of checking allocation of plots within FCT in order to reduce and stop the cases of mixed up or double allocation of plots within the FCT.
- b. To provide an opportunity for the department on how best information on plots or land allocation can be carried out.
- c. To provide means of generating summaries of the allocation of plots or land within FCT.
- d. To provide appropriate security to the nature of information collected and held.
- e. For the system to allow interactive and batch mode of processing for the preparation of the best methods of allocation of land or plots within FCT which could be monthly, quarterly or yearly reports of the allocation.

1.6 STATEMENT OF PROBLEMS

These are the factors that leads to the mixed up or double allocation of plots or land within the Federal Capital Territory:

- a. Lack of proper recommendation record by planing division;
- b. Changes in the recommendation earlier made from planing unit by the authority or management;
- c. Lack of proper communication between the authority or the management and the allottees of the plots or land;
- d. Subdivision of plots and renumbering (NEW NOS);
- e. Lack of proper allocation procedures;
- f. Lack of proper records from Carto Unit.

1.7 COMPONENTS OF GIS.

GIS have three very important Components namely:-

- a. Computer hardware;
- b. Sets of application software modules;
- c. A Proper Organisational context.

These three components need to be in balance if the system is to function satisfactorily.

(1) Computer hardware

The general hardware components of a GIS are as presented in the fig.1 below. The Computer is link to a disk drive storage unit that provides space for storing data and program.

A digitiser used to convert data from maps to the computer.

A Plotter is used to present the result of the data processing and a tape drive is used for storing data or program on magnetic tape.




The user controls the peripherals (a general term for plotters, printers, digitisers and other apparatus link to the computer) via a visual display unit. (VDU) otherwise known as a terminal. The user terminal might itself be a microcomputer special hardware to allows maps to be displayed on the screen quickly GIS software modules.

There are five basis terminal modules constitute the software packages for a GIS.

These modules are sub-system for:-

a. Data input and database verification;

- b. Data storage and database management;
- c. Data out put and presentation;
- d. Data transformation;
- e. Interactive with the users.



Data input covers all aspects of transformation of data captured from existing maps, field observation and sensors into compatible digital form. A variety of computer tools are available for this purpose which include VDU, the digitisers, and so on.




Data storage and database management concern the way in which data bout the position linkage (topology) and the attributes, of geographical elements (points, lines and areas representing objects on the earth surface) structured and organised.

*The organisational aspect of GIS

The five technical subsystem earlier mentioned govern the way in which geographic information can be processed but they do not however on themselves guarantee effective usage.

In order to be used effectively, the GIS needs to be placed in the appropriate organisational context. It is simply insufficient for any organisation to purchase a computer and some software.

To do this properly requires necessary investment in hardware and software and retraining of personnel and managers to use the new technology in proper organisational context.



1.8 LIMITATION AND SCOPE OF THE PROJECT

The limitation of the project is that it should covers and check whether the plots with certain number "A" has been allocated initially using the key field name that will be introduced later in the project. And the scope of the project is that the project will be design in such a way that all the plots numbered within a layout of any district should be registered in the computer and when allocated, there will be source code or key field name to detect the status of the existing plot within the district.

1.9 RELEVANCE OF THE PROJECT

The relevance of the project cannot be over emphasised because with the introduction of source code or key field name, a plot within a district cannot be allocated to two applicants because as it is inputted into the computer the key field name or source code shall be able to detect that plot number "A" has been allocated already, thereby the issue of double allocation, i.e. one plot allocating to two applicants will be eliminated.

CHAPTER TWO

LITERATURE REVIEW

2.1 <u>DEVELOPMENT OF GEOGRAPHIC INFORMATION</u> SYSTEM (GIS).

Geographical information system are becoming more and more popular and widespread among commercial and administrative organisation and, reflecting this trend. GIS have excellent facilities for data management and data display, but they do not have all the facilities for data analysis that many users would like to see. Geographic information system which is a computer based system for collecting, storing managing, retrieving, transferring, displaying, querying and mapping spatial data from the world for a particular set of purposes. Digital mapping overlaps by more than ninety percent, with GIS. In addition to being able to provide a digital map and GIS has the capability to provide spatial analysis to the end users.

2.2 DATABASE MANAGEMENT SYSTEM (DBMS)

Database management system (DBMS) were designed to facilitate storage and retrieval of large data collection they include facilities to secure and project data, enforce consistency of the data stored and make data available to multiple users at the same time.

All data for geographic information system (GIS) have to be converted to numeric value by the database software package before they can become useful for GIS processing and operation. At this point I feel that it is unnecessary to discuss the role which database systems play in information industry in general, give the basics concepts of data base systems, their characteristics and an overview of the component special attention shall be paid to the database in GIS and mapping applications.

In the computer environment the term database is used specifically to indicate data stored in a computer storage media. A data processing systems that uses database is termed a database system.

I shall discuss databases in the context of database systems because databases without data processing systems have no sense in the computer environment. The five components of a database system are as follows.

- a. A Collection of data stored on computer compatible media;
- b. Hardware to enable input, processing and presentation of data;
- c. Software for handling the task stated above;
- d. Personnel to operate and manage the system;
- e. Documentation.

The creation of a database is a complex and time-consuming task, which may be accomplished in two ways:-

- 1. Design and implementation of database system;
- 2. Collection and input of data.

While the second phase is as a rule entirely the responsibility of a user the first phase is more or less heavily supported by computer manufacturers, software designers and database theory.

In the order to design a database system, we have to create an image of the real world in the computer memory and provide the means to retrieve it. A user is usually not interest in such a total view, but only in a partial "user view" i.e. only in those aspect which are most relevant for information the user needs. It represent an efforts to make sense and understand a specific aspects of environment, such matters of interest may be for example: Land registration, Land use Utilities, Soil or multipurpose cadastral and further geology, vegetation, urban and rural development. To bring order into "Geo environment" individuals object send phenomena must be recognised. Such objects and phenomena form the building blocks for the database.


To represent a features in a computer in comprehensive way two types of data are required, (1) positional or graphic data and (2) attributes or semantic data. The positional representation should describe the position of a features and eventually its shape and size, while attributes data should give all other characteristics or properties of the features.

For example in case of a cadastral parcel, the position, shape and size may be represented by the co-ordinates of the corner points, while the attributes may includes owner, user, land use type etc. Which is the main focus of this project.

For a database system to be of economic sense usually many users share a database. The initial major step in design of the database system involves the analysis of the user views and their transformations into a common system comprising all individual view (conceptual view) in a database, a data item is the smallest data unit, which can take part in processing independently and meaningfully. e.g. an X-co-ordinate. A record is a storage unit, which may be directly accessed by a program and represent collection of items.

The graphic database contains mainly positional data. There are three basics types of graphic elements. Point, Line and Area.

A surface is 3-d graphic element.



All graphic element may be represented in 2 or 3 dimensional space.

Two system for representation of positional data have been developed.

Point (vector) and cell (Raster). In the point system a point is of the basic elements of representation. The position of a point may be uniquely defined by a pair co-ordinates (2-d system) or a triplet of co-ordinates (3-d. system) and stored accordingly.

In a cell (grid) system an atomic element is a cell which is an arial unit, usually a square. The whole region is covered by cells and cells are stored in a predefined order, the storage location of each cell determined uniquely its position. An isolated cell represents points. A line elements is defined as a sequence of cells each with no more than two neighbours and an areal elements is simply defined by agglomeration of cells of the equal attributes.

TYPES OF DATABASE INCLUDES:-

- 1. Network database It represent a method of arranging data in a database so that explicit connection and relations are defined by links or pointer of many to many types.
- 2. Hierarchical database It represent data as three structures, composed of hierarchy of data records. Computer files are arranged so that unit of data storage is connected in a hierarchically defined pathway.
- 3. Relational database It represent data as a simple collection of 2 dimensional tables, a relational structure is a method of structuring data relations between different entities and transformation.

2.3 MICROSOFT ACCESS COMPUTER PACKAGES.

Microsoft access computer package is one of the database management packages that are used for storing retrieving data from the database.

There are different ways, one can get started with Microsoft e.g. In some situation, the users of a shared database may not all be able to upgrade to Microsoft Access'97. You can share the database with users of different version of Microsoft Access'97, without having to alter your original database. One can upgrade part of your database to Microsoft access such as Microsoft access 97 so that it can take advantage of many new features and the original unchanged database for users of previous version. Users of all version can share the same

data. You can use this strategy whether your database is in one file or it is in a front end/back end application.

2.4 THE PRINCIPLE BEHIND GIS - OVERVIEW.

There have been paralleled developments as using computers for mapping and spatial data analysis in automated data capture, analysis and presentation in several broadly inter-related fields. These fields surveying and mapping, thematic cartography, Civil Engineering, geography urban and rural planing, remote sensing and image analysis, military applications etc. Consequently there has been much duplication of efforts and a multiplication of discipline specific jargon for different application in different places. This multiplicity lacking many kinds of spatial data processing together into truly general purposes geographical information system.

Essentially all these discipline are attempting the same sort of operation namely to develop a powerful set of tools for collecting sorting, retrieving at will, transforming and displaying spatial data from the world for particular set of purposes. It is this set of tools that constitute what is known as geographic information system.

Geographical data describe object from the real world in term's of:-

a. Their position with respect to known co-ordinate system;

- b. Their attributes that are unrelated to positions (such as cost, colour, texture, Ph etc) and
- c. Their spatial inter-related with each other (topology).

Geographic information system do have a lot in common with computer aided design (CAD). System used for drafting a variety of technical objects. Both GIS and CAD systems need to be able to relate object to a frame of reference, both need to be able to handle non-graphical attributes and both need to be able to describe topographical relation. The major difference between GIS and CAD are the greater volume and diversity of the data input into GIS system and the specialised nature of the analysis methods used. There differences can be so large that an efficient unsuitable for GIS and vice-verse. GIS should be thought for as being very much more than means of coding, storing and retrieving data about certain aspects of the earth surface. In a very real sense the data in a GIS whether coded on a piece of paper or as invisible marks on the surface of a magnetic tape, should be thought of a representing a model of the real world.

This is because these data can be accessed transferred and manipulated interactively in a GIS, they can serve as a test bed on studying environmental processes or for analysing the result of friends, or of anticipating the possible results for planning decisions. By using GIS it is in principle possible for planners and decision-makers to explore a range of possible scenarios and to obtain an idea of the consequences of a course of action before the mistakes or blunders have been irrevocably made in the landscape itself.

2.5. IMPLEMENTATION OF GIS

In order to develop geographic information system that are capable of disseminating comprehensive property information, a change in formation philosophy and practise is required, therefore since GIS software originally operated in standard mode.

GIS increasingly form part of a complex data processing environment. This makes the process of choosing and bench making a GIS is challenging task, which requires structured approach. GIS are rarely soft contained and is also necessary to consider the form of data transfer and the network environment.

CHAPTER THREE

SYSTEM ANALYSIS AND DESIGN.

3.0 Before a computer can be used within a business or an organisation, to carryout task previously under taken by other means. It is important to examine the established procedures by which the business operate to see how they need to be changed to enable the efficient used of the computer. And this study is called system analysis which usually result in the design and implementation of a completely or partially new system.

It involves, analysis of all the different activities of the organisation developing detail procedures for collecting, manipulating and evaluating of all the related data. And the reason for the analysis to understand better activities of the establishment and the stages includes the following:-

- a. Feasibility study;
- b. Investigation and facts reading;
- c. Design and implementation;
- d. Data analysis and review.

3.1. THE EXISTING SYSTEM.

The present system that is existing is the manual methods of land allocation within the FCT by the department of land, planing and survey where the particulars of the applicants are compiled and also short listed by the recommending officers. And the first to analyse here is the organisation's main objectives of the system, based on the phases mentioned above which includes:-

The main reasons for the feasibility study is to be able to look at the project that is sufficient to department to be able to provide first and update information which will satisfied the reason for the new system. At the course of this study data was collected about the difficulties faced with the existing system which includes slow access to files- it is not always easy to access information contain in the file because of too much volumes of files which are filed manually.

- b. Less security and privacy of files As files are manually kept which sometimes not properly kept, there could be less security and privacy of files which could lead to lost of data or information.
- b. Misplacement of files This misplaced of files is carried after accessing it for an information which normally result in days of

delay in accessing the files at another time. Thereby as a result delay the management decision since they are based on files.

3.2 ANALYSIS OF THE EXISTING SYSTEM.

From the existing system it was observed that the land allocations within FCT by the department of land, planing and survey record keeping and retrieving has not being easy, with the problems and difficulties mentioned above, thus I concluded that there is the need for new methods of land allocation procedures, with the studying how the existing system work. Facts studied are as follows characteristics of land allocation unit affected by the system analysed reports and strength operation. For record updating, record keeping and record generation will be included in the new system.

Thereby reducing the management cost and reduce duplication of records and save time which will be easy to retrieve information about a particular plot or piece of land.

3.2.1 INVESTIGATION AND FACT RECORDING:-

The main purpose of this study is to fully understand the existing system and to identify the basic information requirement. And before the investigation commences it is very

important for the analysis to be absolutely clear about the objectives of the suggested computer application as defined by management. The main part of the investigation consist of facts finding exercise aimed at finding out how the work is currently performed, by whom and in what circumstances which includes the details examination of the existing manual system.

- Gathering of all relevant information by questionnaire, personal contact with staff members of the department of land planing and survey.
- Going through the existing records.

3.3 THE NEW SYSTEM.

The new system for the land allocation within FCT the department of Land, Planing and Survey shall be computer system based which will make the allocation faster, without duplication of record and to reduce management cost, which can be retrieved easily.

3.4 DATA COLLECTION AND INFORMATION GATHERING.

Data collection and the information gathered were done through the interview, asking officers in charge of land allocation within the department and also going through the existing records.

Basically, land allocation's applicants files is made up of the following entries:-

- 1. File Name i.e. applicant Name;
- 2. File No.
- 3. State of Origin;
- 4. Cad Zone;
- 5. Map sheet;
- 6. Plot no.
- 7. District;
- 8. Developmental phase;
- 9. Date of recommendation;
- 10. Date of allocation.

And the office analysis of the land allocations of Maitama district will be included in its files as mentioned above.

The report layout obtains from the department of land planning and survey shown below.

- (e) inter action with the user.



A plotter or other king of display device used to present the result of the data pioneering and a tape drive is used for storing data or program on magnetic tape.



The user's terminal might itself be a Computer or might incorporate special hardware to allow maps to be displayed on the screen quickly.

There is a very wide range of these devices that can be used to fill these general hardware requirement.

3.6 DATABASE DESIGN AND ANALYSIS.

CHARTER FOUR

SOFTWARE DEVELOPMENT AND IMPLEMENTATION

4.1 Principles of good Programming Technique.

A program is defined as series of instructions give in a computer to perform a specific task. However, certain laid down rules must be followed such program. Rules of programming can vary from software to software and can be simple or complex.

Until Twenty years ago Computer programs were generally designed and written in an ad-hoc fashion. However, over the last few decades, some ground rules for the construction of goods programs have been laid down.

They include:

- 1. Establish and use a standard, easily recognisable way of expressing problem solutions (structured programming).
- 2. Design algorithms in stages, starting with a rough outline of the algorithm, and successively introducing more detail (Topdown programming).
- 3. Divided an algorithms into separate chunks (modules) and deal with each module separately.
- 4. Give data a central role in algorithm design.
- 5. Describe fully and clearly what each algorithm does and how it does it (documentation).

6. Design and use test data in a systematic manner.

As such rules were developed, a great similarity between the design of programs and normal engineering design techniques was noted, and the term software engineering was coined to describe this approach.

4.1.1 CHARACTERISTICS OF GOOD PROGRAM

The following items are identified as the characteristic of good programs.

4.2. Executable and Correctness.

A good program must be correct. The program should carry out the task it was designed to do without error. In order to achieve this objective, a complete and clear specification of the purpose and functions, of the program must be obtained. Thus, program errors can be due to outright mistakes on the part of a programmer or to a lack of a clear description regarding the required output of the program.

4.2.1 Understandability

A good program must be understandable.

Although a computer program is a set of instructions for a computer, it should also be comprehensible to other people. A person other than

the author should be able to read and understand the purpose and functions of the program.

High-level programming languages such as PASCAL are intended for human use and interpretation in their direct form and are intended for machine use only indirectly through compilation.

4.2.2 Easy to change

Changes in products, changes in company procedures, new government regulations and the like all lead to the necessity of modifying existing computer programs. As a consequence, most established computer installations devote considerable time and effort to changing existing programs. Thus, a good program not only fulfils its original purpose, but also easily adaptable in response to a changing environment.

4.2.3 The Program must be Efficiently Written.

This concerns the amount of time spent in writing the program. This objective is secondary to the program being correct, the easiest way to write a program quickly is to write it partly correct leave it difficult to understand, or allows its obscurity to make it difficult to change. Still, the principal cost of programming project is the programmer's time

and programming techniques which economise this time while still satisfying the objectives that the program be correct, understandable and easy to change are preferred.

4.2.4 Executable

A good program must execute efficiently. The program should be so written that it does not use more computer storage or more computer processing time than is necessary. Again, this objective is also secondary to the primary objectives that a program is correct, understandable and easy to change.

A program should however be alert to the techniques by which efficient program execution can be achieved.

4.3 **ALGORITHMS**

An algorithms can be defined as a set of unambiguous rules that define how a particular problem or class of problems can be solved in a finite sequence of steps. In other words, algorithms is a finite set (or sequence) of instructions (or operator) for carrying out a specific procedural task.


