## CHAPTER ONE

#### INTRODUCTION

1.0

A computer can be defined as a machine which accepts data from an input device, perform arithmetic and logical operations in accordance with a pre-defined program and finally transfers the processed data to an output device either for further processing or in final printed form.

Today computers are active in almost all divisions of sciences and Technology and are doing their jobs efficiently. Apart from pure computational work, they control production processes, run traffic, handle statistical work, do economic planning, gather and process in formation and solve logic and other problems.

All computers may be divided into two broad classes, analog and digital. In turn each of these two classes may further be subdivided into general purpose machines capable of tackling a wide range of mathematical problems, and special purpose machines dedicated to a narrow class of problems or even a specific problem.

The historical background of information management or processing information is something that has started right from when man came into existence. However, like a talent or raw data and raw material are of limited importance, this data becomes useful when they are examined, analyzed, summarized, compared and classified then it becomes a useful information for management to use. Over two hundred billions papers are sometimes found in files nearly one hundred millions file drawers are generated annually by some nations or organizations. The offices are filled to the brim

and the store rooms sometimes cannot contain any more file, some of the store rooms contains up to one trillion pieces.

Going by the figures, there was the need for an automated data processing. The setting of industrial revolution and over increasing amount of data to be processed in a shorter way and shorter times, business felt the need for faster, cheaper more efficient method of processing data.

Record or information is the life wire of every organization, regardless of the type of the organization and also the size of that organization. The importance of information otherwise known as record keeping cannot be over - emphasized.

It is inline with this that one realizes that so many problems are associated with the manual information processing method or the current method. It is seen clearly that right from time or historical background piece of papers are still being piled, they result into two bulky papers, this bulky papers tends to create problems in addition to the ones mentioned earlier.

The other problems are:

- (a) Cost of the papers that are in use is much.
- (b) Papers occupied too much space which can be use for another thing.
- (c) Storage method of such papers is faulty.
- (d) Retrieval of such information sometimes becomes increasingly difficult.
- (e) Security of such information is doubtful.
- (f) The accuracy of such information is not certain.

There are more to this problems, this is just to mention but a few.

Going by the advantages attached to the computerize over the existing method, the researcher took it upon himself to the computerization of the student personal record of Niger State Polytechnic Zungeru.

The identified solution was to computerized the existing method, programs were designed and written, which is aimed at taking care of adding more information, deleting of records, sorting of records, updating of records and viewing of records.

Analysis of the programs is given and a users manual is provided to guide whosoever is handling the program for the first time.

## **CHAPTER TWO**

#### 2.0 HISTORICAL BACKGROUND OF THE INSTITUTION

The institution started as a college of basic studies. It was then known as Zungeru College of advanced Studies(ZUCAS). It came into existence in January, 1977. This college along with eleven others were established for higher education opportunities in the states they are located. The states were educationally disadvantaged, they also had manpower problems because they were unable to produce candidates to fill their quota in universities and other institutions of higher learning.

The instrument establishing the college, that is the Niger state education No. 7 of 1979 specified the objectives of the college as:

To provide for basic studies, training and research in Arts, Science and technology for the purpose of university entry requirement; and to offer courses at sub-degree level in these and other related subjects of study with the ultimate purpose of service to the community.

As a result the college trained students for preliminary courses at I J M B level and also candidates with deficiency in 'O' level credits were admitted for remedial programme.

Apart from these, two diploma programs were introduced one in Mathematics Education and the other is Diploma in Hausa, Arabic and Islamic studies.

However, the two Diploma programs were taken out of the college in 1985 by the state government in order to concentrate on the main objectives of the college, that is basic studies training. Mathematics Education was transferred to the state college of education while Diploma in Hausa, Arabic and Islamic studies was transferred to the college of Arabia and Islamic legal studies.

A total of 1,494 candidates have benefitted from the preliminary I J M B programme, out of which 1,1109 got the required qualification for university direct entry admission.

The college was converted into a state polytechnic in October, 1991. The higher state Edit no. 9 of 1991 which established the institution specified it's objectives as:

To provide instruction, training and research in science, Technology, commerce, humanities and management. To offer special courses in these and other related areas with the ultimate purpose of service for the community and offer courses in technology at certificate and Diploma levels.

The polytechnic started with four departments namely:

- (i) Department of General and Libraries studies.
- (ii) Department of Environmental studies.
- (iii) Department of Science and preliminary studies.
- (iv) Department of Accounting, statistics and computer.

The Department of General and liberal studies is handling the teaching of English and General studies for all the Departments. In addition there were Diploma and Certificate programs which were phaseout in 1995. The courses were: (i) Diploma in Hausa.

(ii) Diploma in Islamic studies.

(iii) Certificate in Hausa.

(iv) Certificate in CRS.

(v) Certificate in Theater Arts.

The Department of Environmental studies handles Diploma in land management, and Diploma in rural Development, the Diploma in Rural Development was phased out in 1994.

Department of science and preliminary studies started with Diploma in integrated science and certificate in laboratory technology.

the Department of Accountancy, Statistics and Computer Science started with:

- (i Diploma in management studies.
- (ii) Diploma in Statistics.
- (iii) Certificate in supervising management (now referred to as certificate in Business management)

(iv) Certificate in Assistant stores officers course.

Presently there are seven departments handling additional programs as follows:

#### LITERATURE REVIEW

Retrieval of information takes a very long time where you have up to 3000 files, the ability to get out a particular information takes a very long time.

Security of such information is questionable. Such files or papers are left and every one has an easy access to them. Accuracy of such information are doubtful sometimes you see papers flying from such files. The information contained in such files are inadequate as some papers are missing.

Corrections of some of such information is nothing to rely on, going by the missing papers such information might have no meaning, when you read through the papers.

According to some cultures enumerating further on the problems associated with manually information processing system. In his book title "INFORMATION TO THE COMPUTER, THE TOOL OF BUSINESS WILLIAM .M. FLIORI" has this to say.

Over 300 billion pieces of paper filling nearly 100 million file drawers are generated annually by the nations business (U.S.A.) papers piled up over the years in offices and store rooms through out the nation over one trillion piece. The business community started thrilling with this volume of papers. it is advised to take the automated information processing.

INFORMATION TECHNOLOGY AT WORK BY DICK DAVIES has this to say "In the traditional office information is stored on paper, it has recently been estimated that in the U.S.A. there are around 200 million sheets of papers stored in offices. These are being added to at the rate of one million per day.

Storing information on papers causes two problems.

- (i) Where to store it all. The file have to be protected from fire, etc. by storage in metal filing cabinets, the space taken up by these cabinet must be rented.
- (2) How to find this document when needed when information are required, it takes time before they are seen.

In our ministries or government organizations, some people use this system to make money, when your file is in process, some clerks retrieve this files and hide them until when they are bribed, then such files are released.

In fact, so much have been said concerning the problems associated with manual way of processing information.

The students of Niger state polytechnic Zungeru will not be free from such problems since, they operate the same way.

In another book by Andrew L. Friedman with Dominic S. Cornford, titled Computer System Development History, organization and implementation has this to say.

The advances in data storage and data access that would make the computer a suitable media for storing information and that would make the computer system suitable for the transmission of data, still lay in the future. The early applications of the computer were largely confined to areas of the firms information processing that conformed most closely with the computers' capabilities- applications that involved simple arithmetic operations on a large number of transactions., These were primarily high-volume, routine, clerical activities.

There are a number of reasons why these activities were the first to be computerized. The importance of high-volume was directly related to the cost of carrying out the process without a computerized system and thus the potential gains that the system could offer.

In January 1954 the first business Dp applicator in the UK, the payroll for J. Lyons, was processed on the LEO Computer. Payroll is the business application 'par excellence' of the first phase of computerization.

As well as being the most frequently computerized application during this period, it embodies many of the characteristics of all early business applications.

In the same book titled Computer Systems Development History, organization and implementation by Andrew L. Friedman with Dominic S. Cornford has this to say. The number of clerical office workers had been growing rapidly from early in the twentieth century.

In UK in 1920 they represented 6% of all workers. By the early 1960s they represented 14% (Friedman, 1977, pp.203 and 222). They thus represented a growing element in firms overall costs.

This clerical functions were ripe for computerization to save the reduction in clerical manpower.

The advantage of the computer is that data, once collected, can easily be structured in many different ways with different degrees of details.

In another book by Elaine Mullins titled Information Processing Students book has this to say 'Each business has its own reason for computerizing its office functions.

The most common reasons are:

- (1) Existing system are unable to accommodate the rate of growth.
- (2) Delays in output of information (turnaround time).
- (3) Delays in retrieving and collecting information.
- (4) High error rate in output.
- (5) Inefficient and time wasting procedures, often involving duplication. Any one of the above could result in reduced company growth, loss of business, reduced profits, projection of a poor company image and the lowering of staff morale.

Another has this to say, in the book titled Analysis and design Information system by James A. Senn. The benefits of computer aided tool. Information further improved the benefits of using tools. The time needed to perform tools decreases, labour intensity is reduced procedures are followed constantly and data describing the system and captured for storage in computer readable form.

- (1) Decrease Elapses time.
- (2) Automated tedious task.
- (3) Ensure Consistent Procedures.
- (4) Capture System Date.

In a related development in the book titled introduction to the Computer, the tool of business by WILLIAM .N. FUORI has this to say "Regardless of whether the system used to process the data is manual, mechanical or electronic, certain fundamental operations are:

- (1) Recording
- (2) Classification
- (3) Sorting
- (4) Calculating
- (5) Summarizing
- (6) Reporting

He went on to explain them this way.

Recording is the transcribing of date into a permanent form. -Classification or grouping of like terms or transaction.

Sorting arranging of data into sequence according to common characteristics. Calculating or computing is the adding, subtracting, multiplying or dividing of raw data to produce useable result.

Summarizing involves the consolidating of data, emphasizing main points and tendencies.

Reporting once the data have been summarized, they must be reported to management or other concerned user(s).

#### 2.3 FEASIBILITY OF PRESENT SYSTEM

The present system is operated manually. The students affairs department is in charge of students registration in the polytechnic.

The duties of the students affairs office are as follows:

a. To give registration number to new students.

b. To compile list of students during registration. Or computing the list.

- c. To compile students data in conjunction with the academic registrar.
- d. Prepare student and staff identity cards.
- e. Issue hostel form.

#### STUDENTS RECORDS IN NIGER STATE POLYTECHNIC ZUNGERU

Students are issued with forms immediately they come back from the end of session break including new students since forms are designed in such a way that the necessary information or record required of a student can be found there.

#### STUDENT PERSONAL DATA

All his/her personal data as name, date of birth, place of birth, local government, home town, residential address, postal address, sponsor, expected year of graduation, next of kin, medical report and so many other things, in addition you have mother's place of birth, Registration number, religion, State of origin.

A copy of the form is shown below:

The next place for registration is the bursary's office the bursar signs the form and writes the student's name. The next person that signs the form is the Students Affairs Officer. Officer in charge certify that the above named student has been registered into the polytechnic his\her registration number is.... ID card to be issued. the student affairs officer signs and write the date.

The student moves from there to the department he\she is admitted. The H. O. D. signs too and register the student concerned. The student then moves to the clinic where he registeres and is issued with a medical card.

The coach is also not left out, the coach signs and registers the students name. The admission officer then certify the concerned has been duly. The academic afairs

#### 2.4 PROBLEM ASSOCIATED WITH THE EXISTING SYSTEM

All problems associated with the manual information processing system is equally found in the polytechnic's student affairs department such were seen through observation and discussion with the personal of the department.

- They complained of inadequate storage facilities and that is more reason why some files are still lying on the ground.
- They complained of some papers flying away that makes the information inadequate.
- Sometimes you find it difficult to know where a particular student file is, so the whole thing becomes cumbersome.
- 4. When the ex-students comes back for their certificates you find it at times difficult to locate their files, not that such files are not seen but it takes time and the students will have to go round to get clearance from lecturers which takes time.
- 5. A better way of grouping students record is not in existence at all, who is repeating, who is withdrawn and others.

It is in line with these problems that the researcher feels, the system should be changed. The feasibility studies was embarked upon to see how suitable it will be to implement the new system as compared to the old system or manual way of keeping records. Since the Institution was established in January 1977, it has been operating in the manual way and it has been characterized by the above mentioned problems.

#### 2.5 WHY COMPUTERIZE STUDENTS RECORD IN THE POLYTECHNIC

The school which has large number of students need to be computerized, such a system will store large volume of student record in the computer, because no matter the number of students in the school all the school need to do is to buy a computer with a large memory space to store such records in the hard disk of the computer and each time such records are needed, they can easily be accessed they can equally be stored in floppy disk.

#### SECURITY OF SUCH RECORDS

The security of such records will be guaranteed because the password will be used by the data manager before one can have access to such records, this time around is not the question of papers flying away, some records are supposed to be kept in confidence such will be taken care of, sometime you see students just coming to pick up their files just to alter certain records or information, with computerization such students will not have access to such information.

Another very important reason why the records of the students should be computerized is to know who is still in school and who is no longer in school, in fact when one visits the students affairs department, where such records are kept at the open registry, there are students that are withdrawn but their files are still in cabinet not only that there are students repeating but such students records or files are never updated.

The computerization of such department will in no small way help the school financially, the rough estimate spent on buying of files and each producing three files, the estimated market price of the file per one is about ₦10.00.

The number of staff in the open registry are up to four and just two of them can be trained and the rest are sent to other department, where manpower is lacking.

Sometimes when you get to the open registry, you will find out that a particular students record is not found but such records are found in the department, such problems arises as a result of late admitted students and such records are not appended in the existing records, with computerization the data manager will always be informed of the new students and such records will be appended in the existing files.

In summary, computerization is very important and necessary due to the reasons enumerated above.

## CHAPTER THREE

#### SYSTEM ANALYSIS AND DESIGN

3.0

System analysis is defined as the methods of determining how best to use computers with other resources to perform tasks which meet the information requirements of an organization.

Also system analysis is concerned with converting the objectives of management as far as information and data are concerned into methods that are amenable processing by a computer. It is a link between management and software/hardware of computing.

System design is the analysis of the current problem to develop objectives for the proposed system. Systems analysis and design is a process similar to problem solving.

#### 3.1 DATABASE MANAGEMENT SYSTEM (DBMS)

A database management system (DBMS) is a computer based system to manage database or collection of database or files.

In database management system files are designed to allow many programs to share fields or allow many different types of access by student name, by student number e.t.c. When a change is made in field that change is made only once since a field only exists in one location. Most data processing system require access to a master file. If more than one program had to use the same fields of data, these fields of ten are stored in more than one file. This practice causes a great deal of duplicated data to be stored.

#### 3.2 METHOD OF DATA GENERATION

This research was conducted in Niger State polytechnic Zungeru. The study is centered on the computerization of students' personal record of Niger State polytechnic Zungeru.

The information were collected through the most effective methods of data collection. They are through personal discussion or interview and observations.

Interviews were conducted with the students' Affairs official, senior Assistant personal officers, clerks and some students.

I tend to ask so may questions as regard to student's personal record keeping in the institution. I kept in touch with the open registry and found out that certain files were left uncered for, I ask why such files were left there, I was made to understand that no enough cabinet to keep them. And some were for people whose data were not complete.

There are files that the owners cannot be identified at all, because no proper records are kept for such files. Observations in the cause of studies there, when a student comes to ask for his file, it takes these clerks the next one or two hours to get out these files. Sometimes, such files are wrongly shelved, while other time such files are not even found. Another significant observation is the way the papers in such files are allowed to fly out without file tags, such missing papers makers the information inadequate.

Ultimately, statistics based on students' records and reports are needed at all levels, local, state national and international by all persons and organizations interested in the institution or involved in decision making.

#### 3.3 ANALYSIS OF THE PROGRAM.

This chapter gives a brief description of the operational procedures involved in the student's personal record keeping system of Niger State Polytechnic Zungeru.

It also explain the major problems identified in manual record keeping systems. However, having undergone an intensive postgraduate program in computer science, I'm fully convinced beyond reasonable doubt that computer can be used to solve virtually all problems of record keeping, using a well designed program. At the end of this project a computer software will be developed, which can be used to process students' personal record and store these records for future reference.

#### 3.4 COMPUTER PROGRAMMING/CODING

The Niger State polytechnic Zungeru Dbase computer programs for the students' personal record keeping system.

The Dbase II plus is a relational database, a database file is organized in the form of a table made up of rows which are records. The records of a database file must have the same structures and must contain the same type of information.

#### 3.5 MODULAR PROGRAM STRUCTURE (PROCEDURE)

Modular program structure shows the logical relationship between the processes and the way in which data has to be moused to support these activities. Duties to be performed in the modular structure include MAIN MENU. This displays the menu of this new system. It consist of the sub programs to be performed in the system.

#### 3.6 STRUCTURE REGISTRATION

This is for the registration of students in the polytechnic at the beginning of each semester/session.

#### COURSE CODE CREATION

This deals with course to be offered by all the students in the polytechnic for a particular semester.

#### EXAM/CONTINUOUS CREATION

Store scores obtained by students in the Exams/Continuous Assessment.

G.P.A COMPUTATION

The grade pint average (G.P.A) and the cumulative grade point average (C.G.P.A) are being computed for all the students in the polytechnic.

#### FACULTY/DEPARTMENT CODE GENERATION

This deals with the faculty/Department the student is offered admission into for all the students in the polytechnic.

#### **NEW SEMESTER/SESSION**


Prepare the system for fresh registration and data computing.

This part is mainly concerned with the generation of reports on students data.

EXIT

This gets you out of the program.

#### CHAPTER FOUR

### 4.0 SOFTWARE DEVELOPMENT AND IMPLEMENTATION

#### INTRODUCTION




After creating these database files, students' records will be entered in each database file for testing. These file structures are also to be used anytime a new file is to be created either for a new term or a new session.

Security involves the need to protect the corporate information database, its integrity and accessibility as well as prohibiting an infringement on stored files.

There must be clearly laid down personal policies and procedures by the computer centre management. These policies are such that may lead to data/program files destruction.

Having viewed and analysed the features, advantages of both the old i.e. manual system of record keeping and the New that is computerised record keeping system we can safely conclude without contradiction that the computerised (New system is better than the old (existing) one.

# 5.1 **RECOMMENDATION**

Record or information is the life wire of every organization. So the need for computerization of an information management system or record keeping system cannot be over emphasized as this will lead to improvement an efficiency and enhance effectiveness. It also has advantages of minimizing cost from the polytechnic.
