PROF ABERUAGBA MAKES CASE FOR BIOFUEL PRODUCTION

ngr. Prof. Folorunsho Aberuagba yesterday presented the 53rd Inaugural Lecture of the Federal University of Technology, Minna with a call for Nigeria to adopt biofuel production as an alternative to petroleum.

The Professor of Chemical Engineering pointed out

during the lecture which held at the Caverton Lecture Theatre, School of Agriculture and Agricultural Technology, Main Campus, that the country can produce bioethanol, which he said is the current fuel of interest for automobiles on account of its biodegradability and reduced green house emissions.

In the lecture titled: "Catalytic Hydrocarbon Conversions for Transportation and Domestic Fuels Upgrade," Prof. Aberuagba also stressed the need for Nigerian universities and research institutes to collaborate to exploit the country's sea bed and all its geo-political zones for viable mineral resources and catalyst synthesis which are of significance in the cost of petroleum and chemical products.

He opined that to ensure economic diversification, there was the need for a more aggressive reorientation of Nigerians and prudent management of revenues from petroleum resources.

The Inaugural Lecturer, who, in the course of his career has made significant contribution to hydrocarbon conversion research, took the audience through the origin of petroleum, history of oil production, petroleum refining, catalysis among others. In his remark, the Vice-Chancellor of the University, Prof. Musbau Adewumi Akanji, *FAS, FNSBMB*, thanked Prof. Aberuagba for the lecture. He noted that the large presence of indigenes of Minna at the event is an indication of how well the lecturer has integrated with the community, a situation he said is good for the unity of Nigeria.

TETFUND STAKEHOLDERS GET TIPS FOR ACCESSING FUND

he Executive Secretary, Tertiary Education Trust Fund (TETFund), Dr. Abdullahi Baffa has urged stakeholders of the Fund to utilize monies made available responsibly and transparently and be guided by its processes, procedures and guidelines.

He made this call yesterday at the Senate Chamber during an awareness seminar for TETFund beneficiaries.

Represented by Mal. Umar Mari, the ES said most of

the institutions are not conversant with its guidelines or aware of the existence of some of its interventions leading to misunderstanding, hence the sensitisation visit was aimed at enlightening and building effective collaboration with stakeholders with a view to improving access to intervention funds for the improvement of the quality of tertiary education in Nigeria.

The TETFund Boss disclosed that the Fund believes that a strong tertiary education system is the backbone of the economy, therefore all its interventions are well calculated and targeted to bring about a solid foundation for the educational future of Nigeria, adding that they are committed to ensuring quality of tertiary education delivery and improving the global competitiveness in our institutions, which is reflected in their policies, projects and programmes.

Dr. Baffa further revealed that the Fund allocations are aimed at enabling tertiary institutions become world class institutions to improve their world ranking and to achieve this, they intend to work closely with regulatory bodies such as National Universities Commission (NUC), National Board for Technical Education (NBTE) and National Commission for Colleges of Education (NCCE) to ensure that quality and standard are improved and sustained.

The Executive Secretary also stated that in 2016, intervention allocations have tripled for various tertiary

institutions from what was given in 2015 and the fund has succeeded in the following areas of its mandate: The provision and improvement of physical infrastructure in all its 202 benefiting institutions from 2011 to date, remarkable progress in the area of academic staff training and development, sponsorship of academic and non-academic staff to various conferences within and outside the country, launching of National Research Fund (NRF) with a seed fund of three billion naira to support cutting edge research in areas of critical national need and development.

Responding, the Vice-Chancellor of the University, Prof. Musbau Adewumi Akanji *FNSBMB, FAS*, expressed gratitude to the TETFund Boss for the sensitisation visit.

Prof. Akanji noted that the essence of the visit was to facilitate the accessing of TETFund money which will be highly beneficial to the University.

Highlight of the sensitisation was presentation of various intervention lines by Department of Project Management on "Activities, Guidelines and Modalities for Accessing Programme Upgrade/ Physical Infrastructure, Entrepreneurship, Advocacy and TETFund Project Maintenance Interventions" presented by Arc. Ekpenyong Ayi, Department of monitoring and Evaluation on "Requirements of the M & E Department for Accessing TETFund Intervention Funds" by Muh'd Sulaiman.

There were also presentation by Department of Academic Staff Training and Development on "Activities, Guidelines and Modalities for Accessing Academic Staff Training and Development and Conference Attendance," by Aderinoye Abdul-Rahman; Department of Education Support Services on "Activities, Guidelines and Modalities for Accessing ICT Support, Institution Based Research, Academic Research Journal and Academic Manuscript into Books Interventions," by Azuka Chukwumerije and one by Internal Audit Unit on "TETFund Audit Requirements and Financial Returns" by Mrs. Gloria Olotu.

BPP HOLDS TRAINING FOR STAKEHOLDERS IN FUTMINNA

he Bureau of Public Procurement (BPP) has held a two-day training in the University. The training which took place on 8th and 9th August, 2017 at the Senate Chamber, Main Campus was targeted at stakeholders of procurement contract award process.

The Vice-Chancellor of the University, Prof. Musbau Adewumi Akanji *FAS, FNSBMB*, said that the BPP saw a little

hitch in the procurement process flow of the University which brought about the need to organise the training for the stakeholders in the University.

Prof. AKanji, who is also the Chairman of the Procurement Committee, explained that the training is a very important one as it will make everyone understand the fundamental principles of procurement, the process of public procurement to avoid fraudulent and unfair procurement and the sanctions involved in case there is a default of any of these procurement procedures.

The lead resource person, Mr. Lanre Obasa, who is the Sectional Head (Training), BPP, explained that public procurement is the use of public funds by public entities for the delivery of public goods, works and services usually through a third party which is the contractor.

Mr. Obasa said some of the key functions of BPP include: to organise training and development programme for procurement staff, to prevent fraudulent and unfair procurement and where necessary apply administrative sanctions which is why this training is necessary for public offices.

He spoke on the application of procurement methods, fundamental principles of bid evaluation, understanding the public procurement process, complaints procedure and administration, adding that all of the procedures need to be adhered to strictly. understand the proceedings in order to avoid making mistakes that would lead to being sanctioned or penalised, noting that sanctions include suspension of the officer directly involved with the procurement or discipline of the Account Officer of the procuring entity.



importance to the students and first of its kind to be organised in the institution.

Prof. Akanji pointed out that these days, one of the criteria used in ranking universities was employability of the students; not just the theories they learnt in school but the practical ability to use their knowledge to do things outside, especially when government job is no longer not easy to get.

Sharing his experience on SIWES activities, the Vice-Chancellor said that some years back, students deliberately chose places where they would go and make money rather than what they would learn.

He advised ITF officials to come up with good plans on how to address SIWES students problem of allowances and ensure it is paid on time.

The VC urged the participants that the essence of exposing them to the training is not just to get the certificate but to make strong recommendations to the management on how to improve SIWES in the University.

Earlier, the Area Manager, ITF Minna Area Office, Mrs. Ifeoma Ihezue, thanked the University Management for giving them the opportunity to organise the workshop and interact with the present and past SIWES School Coordinators of the institution.

Mrs. Ihezue reiterated that they were already aware of the problems in SIWES and want to address them through the interactive session.
