

PROF IYAKA IS NEW DVC (ADMINISTRATION)

he Governing Council of the Federal University of Technology, Minna has approved the appointment of Prof. Yahaya Ahmed Iyaka of the Department of Chemistry, School of Physical Sciences as the new Deputy Vice-Chancellor (Administration), designate.

In a letter conveying the appointment, the Registrar, Mrs. Victoria N. Kolo, disclosed that the Council approved the appointment at its 122nd meeting held on Thursday, March 9, 2017.

The appointment which is for a period of 2 years in first

instance is with effect from April 25, 2017.

Born on January 10, 1968, Prof. Iyaka hails from Bida, Niger State. He had his early education at Government Model Primary School, Bida, (1974-1980), attended Federal Government College, Ilorin, Kwara State (1980-1985) before proceeding to Usman Danfodiyo University, Sokoto where he obtained his B.Sc. degree in Chemistry in 1992.

He obtained a Master's degree in Analytical Chemistry from University of Ibadan in 1998 and proceeded to University of Abuja for his Ph.D. also in Analytical Chemistry in 2006.

Prof Iyaka joined the services of the Federal University of Technology, Minna in 2002 as an Assistant Lecturer and rose through the ranks to become a Professor of Chemistry on October 1, 2015.

The newly appointed Deputy Vice-Chancellor (administration) has held various administrative positions among which are Head of Department, Chemistry from 2015 to date; Deputy Dean, Student Affairs Division, 2006 to 2010; Dean, Student Affairs, 2010-2013 and Postgraduate Programme Coordinator 2006-2010. He has also served as member, Committee of Deans; Senate Representative on Endowment Fund and other strategic committees of the University.

Prof. Iyaka has supervised many students at B.Tech., M.Tech. and Ph.D. levels. He is widely published in reputable local and international journals.

He is a member of Chemical Society of Nigeria (CSN) and is happily married with children.

FUTMINNA GETS GOLD MINING LICENCE

he Federal University of Technology, Minna has joined the league of licensed gold miners in Nigeria as it recently received the go-ahead by the Federal Government.

This came to the fore on Tuesday, March 14, 2017 when the Vice-Chancellor, Prof. Musbau Adewumi Akanji, *FNSBMB, FAS,* received the Reconnaissance Permit and Exploration Licence issued by the Nigeria Mining Cadastre Office.

Speaking during the presentation which took place at the VC's Conference Room, Main Campus, Prof. Akanji disclosed that Management had last year directed FUTMIN Venture to apply for the licence in other to checkmate the activities of illegal miners operating on the University's land. He disclosed the outcome as

gratifying and congratulated FUTMIN Ventures for the success.

He urged FUTMIN Ventures to start thinking of the investors and partners to bring on board.

Other Principal Officers who spoke at the event commended the VC for his determination to follow through with the idea. They also commended FUTMIN Ventures and the Department of Geology for the efforts which saw the idea to fruition and stressed the need for environmental impact assessment before exploration commences.

The development, they further noted, would boost the University IGR and create other areas of academic development.

Speaking at the event, Director, FUTMIN Ventures, Prof. Shehu Ma'aji described the development as a landmark achievement, which is in line with the economic direction of the Federal Government.

The Head of Department, Geology, Dr. Idris Abdullahi said that with the licence, the University has the option of going into direct mining or bringing in other experts.

He explained that after feasibility studies, the more prospective areas would be placed on mining lease, which is valid for 25 years.

The Reconnaissance Permit is valid for one year, while the Exploration Licence, which is valid for three years and is renewable for two further period of two years each, covers 130 Cadastral Units and an area of 26km² in Bosso Local Government Area of Niger State.

ITF AREA MANAGER VISITS FUT, MINNA

he new Area Manager, Industrial Training Fund (ITF), Mrs. Ifeoma Ihezua, accompanied by other officials of the organization on Monday, March 12, 2017, paid a courtesy call to the Vice-Chancellor at the VC's Conference Room, Main Campus.

aspect of the University's programme, without which a student cannot graduate, noting that 400 Level students would have been turned out for IT by the end of March but due to the recent students' unrest it had to be shifted.

The Vice-Chancellor expressed FUT, Minna's willingness to continue to support ITF. He congratulated the new Area Manager on her appointment and prayed that her time will drive ITF, Minna forward positively.

REMINDER: STAFF APPLICATION FOR EXTENSION OF STUDY FELLOWSHIP

Y ou will recall that on May 11, 2015, a general circular on the above subject matter was issued. The essence of the circular was to check the growing trend of study fellows refusals to apply for extension as and when due. Though the University recorded some improvement following the circular, it has been deemed necessary to **REMIND** all staff on the following existing requirements and the penalties for defaulters:

- i. All applications for extension of study fellowship should be made at least THREE (3) MONTHS before the expiration of the study fellowship award.
- ii. Any staff who fails to apply will have his/her salaries stopped immediately as stipulated in paragraph 3 of the Study Award Letter.
- iii. The salary stopped will only be reinstated on application for extension of study fellowship and to take effect from the date of approval.
- iv. All the salaries stopped when not on approved extension shall be forfeited by the staff.

CALL FOR MEMORANDA

The committee set up to draft the University Policy on Institutional Repository Policy is hereby requesting for memoranda from members of the University community and the general public.
