he Vice-Chancellor, Federal University of Technology Minna, Prof. Abdullahi Bala fsssn, has stressed the need for the University to collaborate with the National Drug Law Enforcement Agency (NDLEA) towards sensitisation and prevention of drug abuse among the youths.

Prof. Bala stated this on Thursday, February 24, 2022 when the State Commander of the NDLEA, Barr. Haruna Kweteshe paid him a courtesy visit at the Council Chamber, Main Campus, Gidan Kwano.

The Vice-Chancellor further expressed the institution's readiness to partner the NDLEA in rehabilitation and counselling of youths who have been involved in drug abuse in view of the Agency's expertise in such. He applauded the Agency for their good works even as he identified the desire by the youth to get rich quickly and live in affluence without working for it as part of the causes of the rise in drug-related crimes.

Prof. Bala who further stated that the University has zero tolerance for drug abuse, said most of the cases recorded are happening amongst the students living off campus.

"That is why Management is making efforts in trying to build additional hostel accommodation on the campus, to be able to monitor their activities to some extent. So with this sensitization, many will be saved form going into that direction as many go into it without knowing it implications," he added. The VC thanked the agency for coming with such proposal as partnering with them will be of great help to the students.

Speaking earlier, State Commander, NDLEA Barr. Kweteshe, said the purpose of their visit is to partner with the University in the area of war against drug abuse, adding that Niger has been selected as the zonal headquarter of Kwara, Kogi and Niger.

Barr. Kweteshe said the agency felt it necessary to seek partnership to carry out anti-drug abuse campaign in the University after the ASUU strike which will go a long way in bringing sanity into the society.

The Commander added that with the partnership of the University, they will succeed with the Contd on Page 3 campaign, as no one is safe from the effect of drug abuse, hence the need to join hands in the campaign.

Highlight of the occasion was the

decoration of the Vice-Chancellor as NDLEA Ambassador by the State Commander.
