n assessment team from the National Universities Commission (NUC) has applauded Federal University Technology, Minna for the mode of operations in the Entrepreneurship Development Centre (EDC), the University Industrial Linkages (UIL)/Advancement Office, and the Students, Industrial Work Experience Scheme (SIWES).

The Team lead, Prof. King David Yawe gave the applause during an exit session with the University Management team on Tuesday, May 16, 2023 at the Vice Chancellor's Conference Room, Main Campus, Gidan Kwano following two-day assessment and evaluation exercise of the three centres.

The exercise was carried out to ascertain the level of compliance to NUC guidelines in the mode of operations and management of the centres.

Prof. Yawe who earlier explained that the Commission has decided that the Nigerian Universities System (NUS) incorporate entrepreneurship studies as a course in the university curriculum in order to produce graduates that are not only self-employed, but also providers employment, further reaffirmed entrepreneurship studies has come to stay in Nigerian universities.

Prof. Yawe who described the products showcased during the exercise and the concept of community service offered by the Entrepreneurship Development Centre as innovations for the University community, also expressed satisfaction with the level of organisation and quality of staffing in the centres.

He further remarked that the University has done an excellent job in the areas of industrial linkages and SIWES programmes, adding that many industries are readily available for partnership.

The Team Lead, however, pointed areas where the University would need to improve.

Responding, the Vice-Chancellor, Prof. Faruk Adamu Kuta who described the observations raised by the team as vital,

also expressed the Management's commitment to working round the clock to bridge the gaps pointed out.

EXCO Mandate Renewed

he Staff Cooperative Multi-purpose Cooperative Society (SCMS) of Federal University of Technology, Minna has declared a net profit of N8,825,753.00 (Eight Million, Eight Hundred and Twenty-five Thousand, Seven Hundred and Fifty Three Naira Only) for the year ended December, 2022.

The President of the Co-operative Mal. Isah Abubakar made the declaration at the 26th Annual General Meeting (AGM) of the Society held on May 18, 2023 at CPES Hall, Bosso Campus.

Speaking at the occasion the Vice-Chancellor Prof. Faruk Adamu Kuta who was Represented by the Deputy Vice-Chancellor (Administration), Prof. Uno Essang Uno, advised co-operators to be mindful of their savings and avoid lavish lifestyles, especially

as such savings may be their fall-back option after retirement.

The VC appreciated the leadership of the Society for their prudence and living up to expectation of members.

Giving further details, the President of the Society stated that in the year ended December, 2022 members will enjoy bonus of 1.5% of their total savings and 5% of their shares.

The society, he said, has membership strength of 1,291 out of which 20 are inactive with a total share capital of Twenty-three Million, Four Hundred and Ninety-two Thousand, Eight Hundred and Ten Naira Only (N23,492,810.00).

The President of the Society stated that the large turnout of members at the meeting attests to the strong support and faith in the EXCO. Such support, he added, will inspire them to achieve greater milestones successes for the Society.

He highlighted that under the Platform Rescue Mission as captured in their campaign manifesto, the process digitizing the Society's account has been completed, adding that when deployed, members can access and monitor their accounts with respect to savings, deductions and outstanding months for loan repayment.

Members unanimously agreed to renew the tenure of EXCO by two years with effect from August 7, 2023.

They also unanimously voted in support of the elongation of loan term from 24 months to 36 months, as well as increasing the

5% to interest rate from 10% and increasing the minimum savings N5,000:00.

At the end of the meeting, Messages were given by the Secretary of PG School, Mal. Mohammed Aliyu represented the Registrar, Mr. Amos Kolo, the Bursar, Mrs. Hadiza Goje represented by Deputy Bursar, Mal. Mohammed Kudu, Mal Aliyu Zarumai representative of the State President and Mr. Oledibe Chidiebere. President of National Examination Council (NECO) Cooperative.

blockchain ecosystem.

Minister, According to the Hon. technology is important to the nation's digital economy drive, and the Fourth Industrial Revolution is comparatively the one that has not relegated the African continent to the background, especially as African nations, particularly Nigeria are actively participating in the revolution.

"Blockchain Technology, Artificial Intelligence (AI), Robotics, Cloud and Quantum Computing, Virtual Augmented Reality, Autonomous Vehicle, Bio-Technology, 5G, Cyber Security, are all disruptive technologies brought by the Fourth Industrial Revolution and Nigeria is one of the, at least, three countries in Africa, that are actively involved in the 4th Industrial Revolution," Prof. Pantami stated.

EXAMINATION ADMINISTRATION AND GRADUATION OF STUDENTS

Some of the associated corrupt practices in examination administration and graduation of students in the Universities are:

- Sale of examination questions and other examination-related information.
- Gratification and inducement to manipulate award of marks and grades.
- Swapping of grades.
- Writing of examination by proxy.
- Direct cheating in examination.
- Delay in the release of results.
- Delay of students from graduating due to poor record keeping and deliberate victimization by staff.
- Manipulation of internal examination processes.

Preventive actions by the Universities

- Adequate intelligence should be deployed in the monitoring of examinations.
- Question papers should be printed on the day of the examination to reduce leakages.
- Careful selection of people of integrity to handle examination.
- Computerization/Automation of the entire record (Academic and Administrative) management system from department to all relevant organ.
- There should be a stipulated time line for lecturers to process results after examinations.
- Introduction of standard record keeping system and upholding of official discipline.
- Enforcement of the University's code of conduct for examination.
- Allotment of manageable number of courses to lecturers.
- Students should be encouraged to read the Students' Handbook to familiarize themselves with examination rules and procedures and sanctions for malpractices.
- Arrangement of seats in the examination halls should be such that the students are adequately spaced to curb malpractices and enhance effective supervision.
- Lecturers should alleviate students fear for examinations by avoiding discouraging comments.
